DIEMUT BUBECK is Lecturer in Political Theory at the London School of Economics. She has worked on feminist political theory and ethics, particularly on the ethic of care debate, and is the author of *Care*, *Gender*, *and Justice* (1995). She also has research interests in Nietzsche and in virtue ethics, and is currently working on a project entitled 'Women: Victims or Agents?'

MIRANDA FRICKER is Lecturer in Philosophy and British Academy Postdoctoral Fellow at Heythrop College, University of London. She contributed to *Knowing the Difference*, ed. Lennon and Whitford (1994), and has published articles in epistemology and social philosophy. Her current work focuses on the idea of an ethics of epistemic practice, and her book *Epistemic Injustice* is forthcoming with Oxford University Press.

MARILYN FRIEDMAN teaches philosophy at Washington University in St Louis. She has published articles in ethics, social philosophy and feminist theory. She is the author of What Are Friends For? Feminist Perspectives on Personal Relationships and Moral Theory (1993) and co-author with Jan Narveson of Political Correctness: For and Against (1995). She coedited Feminism and Community (with Penny Weiss, 1995) and Mind and Morals: Essays on Ethics and Cognitive Science (with Larry May and Andy Clark, 1995).

SALLY HASLANGER is Associate Professor of Philosophy at Massachusetts Institute of Technology. She has published on topics in metaphysics, epistemology, ancient philosophy (on Aristotle's metaphysics) and feminist theory, with a recent emphasis on feminist epistemology, critiques of objectivity and theories of social construction (especially the social construction of race and gender). She was guest editor for a

- JENNIFER HORNSBY is Professor of Philosophy at Birkbeck College, University of London. She is author of *Actions* (1980) and of *Simple-Mindedness: A Defence of Naïve Naturalism in Philosophy of Mind* (1996) and editor, with Elizabeth Frazer and Sabina Lovibond, of *Ethics: A Feminist Reader* (1992). Her published articles and current work are in philosophy of mind, philosophy of language, metaphysics and in those areas of political and social philosophy that have been informed by feminist thinking.
- ALISON JAGGAR is Professor of Philosophy and Women's Studies at the University of Colorado at Boulder. Her books include Feminist Politics and Human Nature (1983), Morality and Social Justice, co-authored with James P. Sterba et al. (1994) and Living with Contradictions: Controversies in Feminist Social Ethics (1994). She is currently working on a project entitled 'Sex, Truth and Power: A Feminist Theory of Moral Reason'.
- SUSAN JAMES is Reader in Philosophy at Birkbeck College, University of London. She is the author of *The Content of Social Explanation* (1984) and *Passion and Action: The Emotions in Early Modern Philosophy* (1998) and editor, with Gisela Bock, of *Beyond Equality and Difference* (1992). She is also a General Editor of Oxford Readings in Feminism.
- RAE LANGTON is Professor of Moral Philosophy at the University of Edinburgh. She has published articles in the history of philosophy, and in moral and political philosophy, where she has drawn attention to feminist arguments about pornography and objectification. She has also published in metaphysics and epistemology, and is author of *Kantian Humility: Our Ignorance of Things in Themselves* (1998).
- GENEVIEVE LLOYD is Professor of Philosophy at the University of New South Wales, Sydney, Australia, and a fellow of the Australian Academy of the Humanities. She is the author of *The Man of Reason: 'Male' and 'Female' in Western Philosophy* (1984, 1993), *Being in Time: Selves and Narrators in Philosophy and Literature* (1993), *Part of Nature: Self-Knowledge in Spinoza's Ethics* (1994) and *Spinoza and the Ethics* (1996). She has published articles on seventeenth- and eighteenth-

century philosophy, on philosophy and literature, and on feminist philosophy.

- SABINA LOVIBOND is Fellow and Tutor in Philosophy at Worcester College, Oxford. Her published work includes *Realism and Imagination in Ethics* (1983), *Ethics: A Feminist Reader* (1992), edited with Elizabeth Frazer and Jennifer Hornsby, and *Essays for David Wiggins: Identity, Truth and Value* (1996), edited with S. G. Williams. Her main philosophical interests are in ethics, feminist theory, practical rationality and the idea of a postmodern 'critique of reason'.
- SARAH RICHMOND is Lecturer in Philosophy at University College London. Her published work has been in the area of continental philosophy, focusing in particular on the relationship between recent continental and analytical philosophy. Her current research is in the areas of ethics and psychoanalysis, with a special concern to explore the insights into moral psychology that psychoanalytical thought can provide.
- NAOMI SCHEMAN is Professor of Philosophy and Women's Studies at the University of Minnesota. She is the editor of Feminist Interpretations of Wittgenstein in the Re-reading the Canon series (2000) and the author of Engenderings: Constructions of Knowledge, Authority, and Privilege (1993). The essays in that book and her subsequent published work and current research focus on understanding the distinctive problems and methods of philosophy in relation to historically specific constructions of identity, with particular attention to especially unstable or 'impossible' identities, such as transsexual or secular Iew.
- ALISON WYLIE is Professor of Philosophy at Washington University in St Louis. She writes on philosophical issues raised by archaeology and on the implications of feminist critiques of science. She is co-editor of *Critical Traditions in Contemporary Archaeology* (1989) and has contributed articles on feminist research in archaeology to special issues of *Osiris* (1997) and *Philosophical Topics* (1995), and to collections such as *Women in Human Evolution*, ed. Hager (1997), *The Disunity of Science*, ed. Galison and Stump (1996), and *Changing Methods*, ed. Burt and Code (1995).



PREFACE

Our authors were presented with an especially demanding task, being asked to introduce the reader to feminist debate in a whole area of philosophy as well as to make a contribution of their own. We thank them all, for their essays, for their flexibility, and for their enthusiasm and encouragement along the way. We are grateful to our editor at Cambridge University Press, Hilary Gaskin, for her help with the project, and to our colleague Chris Janaway for suggesting the Gabriele Münter painting for our cover picture.

There are more influences on this book than are apparent from all its footnotes and the many works cited in the lists of Further Reading. When women first began to make distinctively feminist contributions to philosophy, their work was not supported by the usual institutional structures and it was often not recorded on the printed page. Feminist philosophy forced its way into the academy through the political and practical commitment of women whose intellectual courage and professional daring made books like this one possible. The international profile of the contributions here may hide a particular, more local influence on the two of us. We should like to record a debt to the UK Society for Women in Philosophy, and to its dedicated core members, past and present.
