

Analyses of the ecology, biology and society of past and present-day hunter-gatherers are at the core of this interdisciplinary volume. Since the seminal work of *Man the Hunter* in 1968, new research in these three areas has become increasingly specialised, and the lines of communication between academic disciplines have all but broken down. This volume aims to re-establish an interdisciplinary debate, presenting critical issues commanding an ongoing interest in hunter–gatherer research, covering evolution and history, demography and biology, technology, social organisation, art and language of diverse groups. As a reference text, this book will be useful to scholars and students of cultural and social anthropology, archaeology, biological anthropology and human sciences.

CATHERINE PANTER-BRICK is Reader in Anthropology at the University of Durham. Her research interests focus on health and reproduction, human biology and ecology She has also edited *Biosocial Perspectives on Children* (1998), and co-edited *Hormones*, *Health and Behavior* (1999) and *Abandoned Children* (2000).

ROBERT H. LAYTON is Professor of Anthropology at the University of Durham. His interests lie in social change and social evolution, and he is author of several books including *The Anthropology of Art* (1981/1991), *Australian Rock Art* (1992) and *An Introduction to Theory in Anthropology* (1997).

PETER ROWLEY-CONWY is Reader in Archaeology at the University of Durham. His main research interest is the archaeology of anatomically modern hunter-gatherers, their patterns of land use and resource exploitation, and the ways in which they developed or adopted agriculture. He is editor of *Mesolithic Northwest Europe* (1987), *Whither Environmental Archaeology?* (1994) and *Animal Bones, Human Societies* (2000).
