Theatre and Empowerment

Theatre and Empowerment examines the ability of drama, theatre, dance and performance to empower communities of very different kinds, and it does so from a multicultural perspective. The communities involved include disadvantaged children in Ethiopia and the Indian subcontinent, disenfranchised Native Americans in the USA and young black men in Britain, people caught in cycles of violence in South Africa and Northern Ireland, and a threatened agricultural town in Italy. The book asserts the value of performance as a vital agent of necessary social change, and makes its arguments through the close examination, from 'inside' practice, of the success – not always complete – of specific projects in their practical and cultural contexts. Practitioners and commentators ask how performance in its widest sense can play a part in community activism on a scale larger than the individual, 'one-off' project by helping communities find their own liberating and creative voices.

RICHARD BOON is Professor of Performance Studies at the School of Performance and Cultural Industries, University of Leeds. JANE PLASTOW is Senior Lecturer in Theatre Studies at the Workshop Theatre, School of English, University of Leeds. They are also the editors of *Theatre Matters: Performance and Culture on the World Stage* (Cambridge University Press, 1998).

- RICHARD ANDREWS is Emeritus Professor of Italian at the University of Leeds, UK. He is the author of *Scripts and Scenarios: the performance of comedy in Renaissance Italy* (Cambridge University Press, 1993), and of articles on Italian and European comic drama and opera. He has also been visiting Monticchiello on an annual basis since 1985, witnessing and monitoring rehearsals and performances, occasionally attending script conferences, and recently compiling performance records for the archive.
- RICHARD BOON is Professor of Performance Studies in the School of Performance and Cultural Industries at the University of Leeds, UK. His teaching and research interests lie primarily in political theatre of all kinds, in directing for the stage and in multicultural theatre. He is the author of *Brenton the Playwright* and of a number of articles mainly in the area of British political theatre of the twentieth century, and is co-editor, with Jane Plastow, of *Theatre Matters: Performance and Culture on the World Stage.*
- MICHAEL ETHERTON has lectured in universities in Africa and the UK, and is the author of *The Development of African Drama* and *Contemporary Irish Drama*, as well as articles on popular theatre and on education. - SANJOY GANGULY was active in Communist politics as a student. Disillusioned by its centralist tendencies, he left the party to search for a political culture of dialogue and democracy. He began working in theatre in rural Bengal in the early 1980s. His encounter several years later with Augusto Boal and the Theatre of the Oppressed, coupled with his own passionate commitment to the creation of a more just and equal society, led him to found Jana Sanskriti, an independent organisation committed to the use of theatre to conscientise and empower the communities it serves. With more than thirty active theatre groups associated with the group, Jana Sanskriti is now the largest organisation of its kind in India.
- MICHAEL MACMILLAN is a black British playwright and theatre practitioner. He is currently researching in the area of black British theatre at Manchester Metropolitan University, UK, and was until recently Writer-in-Residence at the School of English, University of Leeds, UK.
- GERRI MORIARTY works as a community artist and arts consultant in the North West of England and in Northern Ireland. She has devised and directed community theatre projects in the British Isles and in East Africa, and has pioneered the use of the arts as a method of public consultation. She has worked with a wide variety of community groups, voluntary organisations, local authorities, statutory agencies and educational institutions, both to develop practical arts projects and to develop policy and strategy. She is currently researching evaluation methodologies appropriate for arts projects working in areas of social exclusion. She is an advisor to North West Arts and a member of the Arts Council of Northern Ireland.
