

## THE LAW OF STRANGERS

From the Nuremberg Trials to contemporary human rights, Jews have long played prominent roles in the making of international law. But the actual ties between Jewish heritage and legal thought remain a subject of mystery and conjecture even among specialists. This volume of biographical studies takes a unique interdisciplinary approach, pairing historians and legal scholars to explore how Jewish identities and experiences shaped modern legal thought and activism. Using newly discovered sources and sophisticated interpretative methods, this book offers an alternative history of the twentieth-century international legal profession – and a new model to the emerging field of international legal biography.

James Loeffler is Jay Berkowitz Professor of Jewish History at the University of Virginia and former Dean's Visiting Scholar at the Georgetown University Law Center. He is the author of *Rooted Cosmopolitans: Jews and Human Rights in the Twentieth Century*.

Moria Paz is a Fellow at the Center for National Security and the Law at the Georgetown University Law Center and a Fellow at the Stanford Law School, and the author of the forthcoming book, *Network or State? International Law and the History of Jewish Self-Determination*.
