SVERIGES RIKSBANK AND THE HISTORY OF CENTRAL BANKING

Written in celebration of its 350th anniversary in 2018, this book details the history of the central bank of Sweden, Sveriges Riksbank, as presented by Klas Fregert. It relates the bank's history to the development of other major central banks around the world. Chapters are written by some of the more prominent scholars in the field of monetary economics and economic history. These chapters include an analysis of the Bank of England written by Charles Goodhart; the evolution of banking in America, written by Barry Eichengreen; a first account of the People's Bank of China, written by Franklin Allen, Xian Gu, and Jun Qian; as well as a chapter about the brief but important history of the European Central Bank, written by Otmar Issing.

Rodney Edvinsson is Associate Professor and Senior Lecturer in Economic History at the Stockholm University, where he also received his PhD, in 2005. He is also Pro Futura Fellow at the Swedish Collegium of Advanced Study. His main research interests include long-term economic growth, historical national accounts and monetary history.

Tor Jacobson is an economist with the central bank of Sweden, Sveriges Riksbank. He received a PhD in statistics at Uppsala University. Tor Jacobson's research interests include econometrics, empirical macro, banking, and empirical micro applications.

Daniel Waldenström is Professor of Economics at the Research Institute of Industrial Economics, IFN, and visiting professor at the Paris School of Economics. He received a PhD in economics from the Stockholm School of Economics and a PhD in economic history from Lund University.

Contributors

Franklin Allen is Professor of Finance and Economics and Director of the Brevan Howard Centre at Imperial College London and has held these positions since July 2014. He was on the faculty of the Wharton School of the University of Pennsylvania from July 1980 to June 2016. He now has Emeritus status there.

Vincent Bignon is a Senior Expert Economist and Deputy Head of the Microeconomic Analysis Unit of the Banque de France, where his research deals with economic history and monetary theory and his policy work analyses the collateral framework of central banks and the regulation of central clearing counterparties. He received his PhD from Ecole Polytechnique in Paris, and has held various academic positions in Paris, Philadelphia and Geneva.

Michael D. Bordo is a Board of Governors Professor of Economics and director of the Center for Monetary and Financial History at Rutgers University, New Brunswick, New Jersey. He has held previous academic positions at the University of South Carolina and Carleton University in Ottawa, Canada. He is a Research Associate of the National Bureau of Economic Research, Cambridge, Massachusetts, and a member of the Shadow Open Market Committee. He has a BA degree from McGill University, an MSc in Economics from the London School of Economics and received a PhD in 1972 from the University of Chicago. He has published many articles in leading journals and thirteen books on monetary economics and monetary history. He is editor of a series of books for Cambridge University Press: *Studies in Macroeconomic History*.

Jakob De Haan is Professor of Political Economy, University of Groningen, the Netherlands and Head of Research of De Nederlandsche Bank. He graduated at the University of Groningen, where he also got his PhD. He has published

extensively on issues like public debt, monetary policy, central bank independence, political and economic freedom and European integration.

Rodney Edvinsson is Associate Professor and Senior Lecturer in Economic History at the Stockholm University, where he also received his PhD in 2005. He is also Pro Futura Fellow at the Swedish Collegium of Advanced Study. His main research interests include long-term economic growth, historical national accounts and monetary history.

Barry Eichengreen is George C. Pardee and Helen N. Pardee Professor of Economics and Political Science at the University of California, Berkeley; Research Associate of the National Bureau of Economic Research; and Research Fellow of the Centre for Economic Policy Research.

Øyvind Eitheim is a director at General Secretariat, Norges Bank. He served as Director of the Research Department at Norges Bank from 2001 to 2009 and has been coordinating projects related to Norges Bank's bicentenary project 1816–2016 and Norges Bank's projects on historical monetary statistics for Norway. He is a co-editor of *Central Banks at a Crossroads: What Can We Learn from History?* (Cambridge University Press, 2016, with M. D. Bordo, M. Flandreau and J. F. Qvigstad) and a co-author of *A Monetary History of Norway, 1816–2016* (Cambridge University Press, 2016, with J. T. Klovland and L. F. Øksendal).

Marc Flandreau holds the Howard Marks Chair of Economic History at the University of Pennsylvania. He received his PhD in Economics from the Ecole des Hautes Études en Sciences Sociales, Paris, in 1993 and is also a former graduate from the Ecole Normale Supérieure in Paris. Flandreau has published extensively on the history of the international monetary system, central banking, exchange-rate regimes, public finance, monetary unions, rating agencies, financial journalism, white-collar criminality, investment banking and the dynamics of financial crises.

Klas Fregert is Associate Professor of Economics at Lund University. His research interest is the interaction between macroeconomic regimes and the institutional structure of the economy in its organisation of labour and financial markets, and the degree of monetisation.

Charles A.E. Goodhart was trained as an economist at Cambridge (undergraduate) and Harvard (PhD). He then entered a career that alternated between academia (Cambridge, 1963–1965; London School of Economics, 1967/1968; again 1985–date), and worked in the official sector, mostly in the Bank of England (Department of Economic Affairs, 1965/1966; Bank of England, 1968–1985; Monetary Policy Committee, 1997–2000). He has

worked throughout as a specialist monetary economist, focusing on policy issues and on financial regulation, both as an academic and in the Bank. He devised ‘the Corset’ in 1974, advised Hong Kong on ‘the Link’ in 1983, and Royal Bank of New Zealand on inflation targetry in 1988. He has written more books and articles on these subjects throughout the last 50 or 60 years than any sane person would want to read.

Xian Gu is an Assistant Professor of Finance at the School of Finance, Central University of Finance and Economics, Beijing. Her research interests are empirical banking and corporate finance. She received her PhD from Beijing Normal University and was a post-doctoral fellow at the Wharton School, University of Pennsylvania. She also served as an economist at CITIC Securities.

Otmar Issing is President of the Center for Financial Studies – Goethe University, Frankfurt, Germany. He was a member of the Executive Board of the Deutsche Bundesbank and thereafter a member of the Executive Board of the European Central Bank. Before becoming a central banker, he was Professor of Economics at the universities Erlangen-Nuremberg and Wuerzburg.

Tor Jacobson is an economist with the central bank of Sweden, Sveriges Riksbank. He received a PhD in statistics at Uppsala University, Sweden. Tor Jacobson’s research interests include econometrics, banking and empirical micro applications.

Jan Tore Klovland is a Professor of Economics at the Norwegian School of Economics in Bergen, Norway.
