Preface to the Second Edition

No one can keep track of all legal developments within the European Union, and any collection on the law of the Union will thus have to be highly selective. This student edition of *EU Treaties and Legislation* presents the most essential primary and secondary sources of Union law. Part I contains the Union's primary law in consolidated form (except for the Treaty establishing the European Atomic Energy Community). Part II then offers a selection of twenty-six pieces of Union legislation in five core areas, which are of importance to undergraduate students of European Union law. Each legislative act is presented in its "Lisbonised" form and in its most updated "consolidated" version. In contrast to the first edition, this second edition now also includes the "Brussels I Regulation" and the "Damages Directive" for breaches of competition law.

An appendix contains extracts of the central United Kingdom acts governing British membership in the European Union: the European Communities Act 1972 as well as the European Union Act 2011. Yet in light of the British decision to withdraw from the European Union, this second edition now also includes extracts from three additional Brexit-related statutes, namely: the European Union (Notification of Withdrawal) Act 2017, the Constitutional Reform and Governance Act 2010, as well as the European Union (Withdrawal) Bill (as originally introduced by HM Government).

Regarding this second edition, thankful acknowledgement is again made to the European Union for its kind permission to reproduce primary and secondary Union law from its EUR-Lex website. It (almost) goes without saying that this student text is not "authentic" and therefore produces no legal effects. With a similar disclaimer in mind, I am equally grateful to Her Majesty's Stationery Office for allowing me to reproduce extracts from its legislation.gov.uk website. I would like to thank Sinéad Moloney for her belief in the original project and Caitlin Lisle for her assistance with regard to this second edition. I continue to be particularly indebted to Eszter Belteki for her "Tables of Equivalences", which are – in my view – the most refined and accurate Tables that presently exist.
