Michael Pollitt is Professor of Business Economics at the Cambridge Judge Business School in the University of Cambridge and a Fellow of Sidney Sussex College, Cambridge. He is chair of the ‘In Search of ‘Good’ Energy Policy’ Grand Challenge initiative of Energy@Cambridge and an Assistant Director of the Energy Policy Research Group (EPRG).

David Reiner is Senior Lecturer at the Cambridge Judge Business School and Assistant Director of the Energy Policy Research Group at Cambridge University. His research focuses on energy and climate change politics, policy, economics, regulation and public attitudes, with a particular focus on social license to operate.

Contributors

Atif Ansar, a fellow of the University of Oxford (Keble College) and Programme Director of the MSc in Major Programme Management at Oxford Saïd Business School, is a British-Pakistani academic of an international reputation. His research on \$1B+ big capital projects – such as large infrastructure; investments in oil and gas, downstream energy, or extractive industry investment programmes; and construction innovations – is widely cited and frequently featured in the media. 2015), ‘Sustainability and Ethics; Reflections on Sustainable Development Goals’ (*Sustainability* – 2018), ‘Ethics in Modern Universities of Technology’ (*Science and Engineering Ethics* – 2018), ‘Risk Governance: New Perspectives’ (*Journal of Risk Research* – 2019) and ‘Multilateral Governance of Nuclear Risks’ (*Risk, Hazard, Crisis and Public Policy* – 2018). Taebi is currently writing a monograph on ethics and engineering (under contract with Cambridge University Press). He is a member of the Young Academy of the Royal Netherlands Academy of Arts and Sciences.

Jonathan Chaplin is a specialist in political theology and a member of the ‘In Search of “Good” Energy’ Project. He received his PhD in political theory from London School of Economics and Political Science and has taught at institutions in the UK, Canada and the Netherlands. He was Director of the Kirby Laing Institute for Christian Ethics, based in Cambridge, from 2006 to 2017. He has written two reports for Theos and is author of many articles and essays in political theology, including ‘The Global Greening of Religion’ (2016) and a forthcoming book chapter, ‘Responding to Earth’s Lament: Public Justice and the Ecological Crisis – Framing a Research Agenda’.

Chi Kong Chyong is Director of the Energy Policy Forum and Research Associate of the Energy Policy Research Group at the Cambridge Judge Business School, University of Cambridge. Kong holds a PhD in energy economics and policy from Cambridge Judge Business School and an MPhil in technology policy from Cambridge. Before coming to Cambridge, he worked as a researcher at the National Academy of Sciences in Ukraine. Since completing his PhD, Kong has been a research associate at EPRG working mostly on natural gas market modelling and Eurasian gas trade relations as well as on energy infrastructure investment.

John Deutch, Emeritus Institute Professor at the Massachusetts Institute of Technology, served as Director of Energy Research and Undersecretary of the US Department of Energy in the Carter Administration. He was a member and Chair of the Secretary of Energy Advisory Board during the Obama Administration.

Søren Djørup is an assistant professor in energy planning at Aalborg University. He has a background in economics and political economy and a PhD in energy planning. He has done research into the markets, regulation and policies in the energy sector and its coherence with the aim of transitioning to a renewable energy system. He applies an interdisciplinary approach where economics and social science are combined with a technical understanding of energy systems.

Leslie-Anne Duvic-Paoli is a lecturer at The Dickson Poon School of Law, King's College London. She teaches and researches in different areas of public international law, with a focus on international environmental law and climate and energy law. Before joining King's College London in August 2017, she was a Philomathia Post-doctoral Research Associate in the Department of Land Economy at the University of Cambridge. Leslie-Anne is the author of *The Prevention Principle in International Environmental Law* (Cambridge University Press, 2018). She is a fellow of the Cambridge Centre for Environment, Energy and Natural Resource Governance and the Project Leader of the Platform on International Energy Governance, a network of excellence that fosters the conduct of research in unexplored areas of international energy law. Leslie-Anne holds master's degrees from Sciences Po Paris and the University of Panthéon-Sorbonne, as well as a PhD from the Graduate Institute in Geneva.

Christian Growitsch has served as Deputy Director at the Fraunhofer Institute for Microstructure of Materials and Systems IMWS since January 2018, where he has also been Director of the Center for Economics of Materials (CEM) since July 2017. He taught economics at the Martin-Luther-University Halle-Wittenberg and University of Hamburg, and from September 2014 to September 2015 he was Managing Director of the Hamburg Institute for International Economics. Earlier, he served as Director of Applied Research and Member of the Management Board of the Institute of Energy Economics at the University of Cologne, where he taught as Associate Professor (*Privatdozent*) of Economics. Christian studied business administration, economics and social sciences in Hamburg and Lüneburg and pursued post-graduate studies in economics at the Universities of Lüneburg and Cambridge, where he was a visiting scholar in 2004. In May 2010 he qualified as a professor at the University of Halle-Wittenberg. From 2007 to 2010 he headed the Department of Energy Markets and Energy Regulation at the Scientific Institute for Infrastructure and Communication

Services (WIK). The focus of his economic research and politico-economic consultation presently lies in the field of applied microeconomics.

Yang Han received his MSc degree in computer science with distinction from the University of Hong Kong (HKU) in 2014. He obtained his bachelor's degree from the Department of Information Systems, Beihang University, Beijing, China, in 2013. He is a PhD student in the Department of Electrical & Electronic Engineering at the University of Hong Kong. His recent work focusses on the spatio-temporal data analysis and its applications in environmental pollution and policy studies in China. He has published in environmental science and policy.

Felix Höffler has published widely in the field of industrial organisation and energy economics. He was Director of the Institute for Energy Economics (EWI) and the Institute for Economic Policy (iwp), both at the University of Cologne. His research interests included regulatory economics, industrial economics, competition policy, energy economics, and law and economics.

Caroline Humphrey is a social anthropologist who has worked in the USSR/Russia, Mongolia, Inner Mongolia, Nepal and India. Her research interests include socialist and post-socialist society, moral economy, the relation between history and anthropology, and the aesthetics of daily life. Until 2010 she was Sigrid Rausing Professor of Anthropology at the University of Cambridge and she is currently a research director at the university's Mongolia and Inner Asia Studies Unit. Her major publications include: *Karl Marx Collective: Economy, Society and Religion in a Siberian Collective Farm* (Cambridge University Press, 1983); *The Archetypal Actions of Ritual*, illustrated by the Jain rite of worship with James Laidlaw (1994); *Shamans and Elders: Experience, Knowledge and Power among the Daur Mongols with Urgunge Onon* (1996); *The Unmaking of Soviet Life: Everyday Economies After Socialism* (2002); *A Monastery in Time: the Making of Mongolian Buddhism*, with H. Ujeed (2013); *Frontier Encounters: Knowledge and Practice at the Russian, Chinese and Mongolian Border*, ed. with Franck Billé and Gregory Delaplace (2012); and *Trust and Mistrust in the Economies of the China-Russia Borderlands* (2018).

Frede Hvelplund is a professor in energy planning at Aalborg University, and has a background in economics and social anthropology. He has a Dr. Tech. degree in social engineering and has written many books and articles on the interrelationship between social science, politics and technological change.

Charlotte Johnson is an anthropologist who studies urban energy transitions. She uses anthropological theory and methods to examine the interaction between social and technical systems, focusing particularly on decentralised energy infrastructure and smart systems in the home. Charlotte works at University College London's Energy Institute collaborating on interdisciplinary research projects

that investigate energy demand. Her work often takes a participatory approach, and she held a public engagement fellowship to run a community energy project in London. She has been interviewed by national print and broadcast media about public participation in urban energy transitions. She has also participated in government and NGO knowledge transfer programmes, providing expertise on resident involvement with District Heating in the UK. Educated at Cambridge with degrees in mathematics and economics, he has managed research projects on utility privatisation and regulation, road pricing, transition from state socialism to the market economy in central Europe, electricity restructuring and market design, and transmission access pricing and has active research on market integration, transmission planning and finance, climate change policies, and the design of energy policy and energy taxation. His books include *Privatization, Restructuring and Regulation of Network Utilities* (2000) and with Joe Stiglitz, *The Theory of Commodity Price Stabilization: A Study in the Economics of Risk* (1981).

Michael Northcott is Professor Emeritus of Ethics at the University of Edinburgh and has been Visiting Professor at Claremont School of Theology, Duke University, Flinders University, Heidelberg University, the Indonesian Consortium of Religious Studies and the University of Malaya. His principal research has been on the religious roots, and ethical implications, of environmental concern and climate change. He has conducted fieldwork in, and published many papers on, the relationship between religion and environmental concern in the UK, the United States and Southeast Asia. His PhD was published as *The Church and Secularisation: Urban Industrial Mission in Northeast England* (1991), and his first major research monograph was *The Environment and Christian Ethics* (Cambridge University Press, 1996). Other monographs include *Life After Debt: Christianity and Global Justice* (1999); *An Angel Directs the Storm: Apocalyptic Religion and American Empire* (2005); *A Moral Climate: The Ethics of Global Warming* (2007); *A Political Theology of Climate Change* (2013) and *Place, Ecology and the Sacred* (2015). His co-edited books include *Diversity and Dominion: Dialogues in Ecology, Ethics, and Theology* (2009), *Theology After Darwin* (2009) and *Systematic Theology and Climate Change* (2016).

Lord Ronald Oxburgh taught geology and geophysics at Oxford, Cambridge, Stanford and Caltech. He was Head of the Department of Earth Sciences in Cambridge and served for seven years as President of Queens' College. He served as Chief Scientific Adviser to the UK Ministry of Defence (1987–1993) and chaired the inquiry into the safety of UK nuclear weapons. He subsequently became Rector of Imperial College. Ron advises the Government of Singapore in matters of environment, water and higher education. He is Chairman of Green Energy Options and zOC, is the former Honorary President of the Carbon Capture and Storage Association and former Chairman of Shell Transport and Trading. He is a fellow of the Royal Society and of the Royal Academy of Engineering, and a foreign member of the US Academy of Sciences. He has served as President of the European Union of Geosciences, and of the British Association for the Advancement of Science. He has chaired the Trustees of the Natural History Museum. Ron was created a life Peer in 1999 and for four years chaired the Science and Technology Committee of the House of Lords.

Marc Ozawa is an associated researcher of the Energy Policy Research Group at the Judge Business School, University of Cambridge. He began his career analysing

the first joint oil and gas ventures in Russia and Central Asia following the collapse of the Soviet Union. More recently, he worked as a research associate for Energy@Cambridge and was the Associate Director of the Energy Policy Forum, University of Cambridge. He held previous research and editorial positions at IHS CERA, Harvard Business School and the *Yale Journal of International Affairs*. His current research examines the role of trust in international relations, NATO-Russian relations and Russian, East European and Eurasian affairs. Marc has an interdisciplinary background that includes politics, economics and area studies. He is a graduate of the University of Alaska (BA), Yale University (MA) and the University of Cambridge (MSt, PhD).

Michael James Platts is Senior Teaching Associate at the Institute for Manufacturing, University of Cambridge. Jim spent twenty-three years in industry. With a civil/structural engineering background, he was a partner in the consulting engineering practice Gifford and Partners and Managing Director of Composite Technology Ltd in the 1980s, where he created the designs, the manufacturing processes, the team and the company that manufactured all the large wind turbine blades in the UK, now the global blade technology centre for the wind turbine company Vestas. For the last twenty-nine years he has been based in the Institute for Manufacturing in the University of Cambridge, where he was Course Director for the Manufacturing Engineering Tripos and Leading Examiner and Tutor for the Manufacturing Leaders' Programme and supervised well over 300 technical development projects in companies. He is involved in leadership training, innovative manufacturing and development projects across many industries worldwide. He has been involved with technology transfer to, and design and manufacturing development of, wind energy technology in China. He served on the Malaysian Palm Oil Board Programme Advisory Committee and coordinated the development of its forward strategy recommendations in 2010, and served on FELDA's R&D Advisory Panel. He brings valuable experience in design and manufacturing, particularly skill-based manufacturing, to projects. His academic interests include ethical leadership, development of skill and competence in design and manufacturing and optimisation of manufacturing processes. He is a Quaker and holds an MA from the University of Cambridge, is a Chartered Engineer and a member of the Institution of Civil Engineers, a member of the Institute of Materials, Minerals

and Mining and a fellow of the Royal Society of Arts, Manufacture and Commerce. He is a member of the Cambridgeshire Ecumenical Council.

Michael Pollitt is Professor of Business Economics at the Cambridge Judge Business School in the University of Cambridge and a fellow of Sidney Sussex College, Cambridge. He is Chair of the ‘In Search of “Good” Energy Policy’ Grand Challenge initiative of Energy@Cambridge and an assistant director of the Energy Policy Research Group (EPRG). His energy research focuses on future electricity market design and regulation for high shares of renewables. Michael has advised Ofgem, BEIS/DECC, the European Commission and the World Bank, among others, on energy policy. He is the author of more than eighty articles and ten books on energy policy and business ethics. He holds an MA in economics from the University of Cambridge and an M.Phil. and D.Phil. in economics from the University of Oxford.

Tim Reilly is a PhD candidate at the Scott Polar Research Institute, University of Cambridge, and a graduate research fellow at the Centre for Rising Powers in the international affairs department at Cambridge. He is the Founder of Arctic Advisory Group, an Arctic risk management and research consultancy. Previous appointments include Government Affairs Adviser to Shell Gas & Power in the Caspian region, as well as work in the Caucasus, Central Asia, Russia and Ukraine for companies such as Chevron and JKN Oil & Gas. His first experience of the (Norwegian) Arctic was as a young paratrooper officer in the 1980s, trained in Arctic warfare. Tim is a Russian speaker and was educated at Cambridge, Durham and the Moscow State Institute of International Relations. David Reiner is University Senior Lecturer at the Cambridge Judge Business School. He is a political scientist and is an assistant director of the Energy Policy Research Group at Cambridge University. His research focuses on energy and climate change politics, policy, economics, regulation and public attitudes, with a particular focus on social license to operate. Specific topics include retail markets, smart meters, subsidy reform, low-carbon technologies, industrial decarbonisation and dynamics of demonstration. Methods include large- and small-scale public and stakeholder surveys, public communications and engagement exercises; and economic, policy and historical analysis.

Sabine Roeser is Professor of Ethics (Distinguished Antoni van Leeuwenhoek Chair) and Head of the Ethics and Philosophy of Technology Section at TU

She has published ten books, five special issues, numerous peer-reviewed articles and book chapters with leading international publishers and journals, as well as numerous articles in other outlets. In 2018 she published her second monograph, entitled *Risk, Technology, and Moral Emotions*.

Emily Shuckburgh is a climate scientist and mathematician based at the British Antarctic Survey (BAS). She leads the national research programme on the Southern Ocean and its role in climate (ORCHESTRA), serves as Deputy Head of the Polar Oceans Team and leads the Data Science Group at BAS. She holds a number of positions at the University of Cambridge (Fellow of Darwin College, Fellow of the Cambridge Institute for Sustainability Leadership and Associate Fellow of the Centre for Science and Policy). In the past she has worked at Ecole Normal Supérieure in Paris and at MIT. She is a fellow of the Royal Meteorological Society and Co-Chair of their Climate Science Communications Group. She has also acted as an advisor to the UK government on behalf of the Natural Environment Research Council. Sandy Skelton is an environmental economist with a particular interest in the motivations and trade-offs associated with greater material efficiency and demand reduction. She holds the Charles and Katherine Darwin Research Fellowship at Darwin College and was awarded a wholeSEM bilateral fellowship to collaborate with the GEM-E3 macroeconomic model. Sandy's PhD focused on the incentives for greater material efficiency in the use of steel. The work was funded by the WellMet2050 project under the supervision of Prof Julian Allwood, University of Cambridge. Sandy has an undergraduate degree in economics from the University of Cambridge and an MSc in metals and energy finance from the

Imperial College Business School. Between degrees, Sandy worked for the policy research consultancy Brook Lyndhurst, advising the public sector on pro-environmental behaviour change policy. Karl Sperling is an associate professor in energy planning at Aalborg University. He has a background in environmental management and a PhD in integrated energy planning. He has undertaken research on strategic energy planning at the city and municipality level, as well as on the past, present and future of community energy and grassroots innovations in the energy sector. He addresses these fields with an interdisciplinary approach, taking as a point of departure his technical understanding of energy systems and a focus on public regulation and economic and social analyses.

Jorge E. Viñuales is the Harold Samuel Professor of Law and Environmental Policy at the University of Cambridge, where he founded the Cambridge Centre for Environment, Energy and Natural Resource Governance (C-EENRG). He is also the Chairperson of the Compliance Committee of the UNECE/WHO-Europe Protocol on Water and Health. Corine Wood-Donnelly is an interdisciplinary researcher in international relations and political geography, with research interests in issues and models of maritime governance, comparative policy, performances of sovereignty and materiality.
