He has published 15 books and over 100 scholarly articles and chapters in the fields of political and legal theory, international law, international organizations, international relations and comparative politics. Before joining Rutgers University, Jean-Marc Coicaud worked for the United Nations Secretariat and the United Nations University in New York and Tokyo, including as a member of the speech-writing team of the United Nations Secretary-General and a research director.

Lynette E. Sieger is a Ph.D. candidate at the Division of Global Affairs at Rutgers University. She specializes in global, legal, and political theory.
