

Reviews in Clinical Gerontology

All material prepared for publication is assumed to be written exclusively for Reviews in Clinical Gerontology and not to have been submitted for publication elsewhere. Before acceptance papers will be refereed with occasional use of outside referees. All authors will be sent a copyright assignment form and this must be returned to the Production Controller at Cambridge University Press, at the time the manuscript is submitted.

Priority and time of publication are decided by the Editor, who retains the customary right to edit, if necessary, material accepted for publication.

Two copies of the manuscript should be prepared and both (with any illustrations) should be submitted to the relevant Section Editor*. Authors should also keep a copy for their own reference.

MANUSCRIPTS, TABLES AND ILLUSTRATIONS

Type double-spaced throughout on one side of the sheet only and number pages consecutively. Authors should include their names and initials, their posts at the time they did the work and their current appointments and qualifications.

The name and address of the author to whom correspondence, proofs and offprint order are to be sent should also be given, together with telephone, fax numbers and email addresses where available. Authors are requested to submit their review on disk (in addition to the 2 typescripts). Disks should preferably be in Microsoft Word or WordPerfect (PC compatible or Macintosh format) and should be labelled with the first author, the software and hardware used and the name of the file to be processed. The publisher reserves the right to typeset material by conventional means if an author's disk proves unsatisfactory.

Drugs should be given their approved, not proprietary names and the source of any new or experimental preparation should be given.

Abbreviations should be spelt out in full when first used in the text.

In the text SI units should be used, but blood pressure should be expressed in mmHg and haemoglobin as g/dl.

Full points should not be used after contractions or abbreviations (except for lower case abbreviations - e.g., i.e., i.v. and no.).

Spelling should follow the Oxford English Dictionary, except that the variant aging will be used.

Tables and illustrations should be submitted separate from the text with legends to illustrations also separate.

Photographs should be prints (not negatives, transparencies or radiographs); they should be no larger than 30 x 21 cm and trimmed to remove excess material. The top should be marked in soft pencil on the back. Patients in photographs should not be identifiable and should have their eyes masked to conceal identity. Any identifiable photograph should be accompanied by written permission from the patient. If material has been published elsewhere, written consent for republication in all forms and media, including electronic publication, must be obtained from the copyright holder and the correspondence submitted with the manuscript. (Please see Copyright below.)

REFERENCES

References should follow the 'Vancouver style' and be numbered in the order in which they appear in the text. The full list of references should give the names and initials of all authors (unless there are more than six, when only the first three should be given, followed by et al.). The authors' names are followed by the title of the article; the title of the journal abbreviated according to the style of Index Medicus; the year of publication; the volume number; and the first and last page numbers of the article. For chapters in books give the names and initials of chapter authors; chapter title; names and initials of editors of the book; the book title; place of publication; publisher; year of publication and first and last page number of chapter. Below are examples of various references:

Authors must verify references against the original documents before submitting the review.

COPYRIGHT

Authors must obtain permission to reproduce copyright material in all forms and media.

Permission to include material not in your copyright. If your contribution includes textual or illustrative material not in your copyright and not covered by fair use/fair dealing, permission must be obtained from the relevant publisher for the non-exclusive right to reproduce the material worldwide in all forms and media, including electronic publication. The relevant permission correspondence should be attached to the copyright form.

Submission of an article implies that it has not been published and is not being considered for publication elsewhere, either in the submitted form or in a modified version. Authors of articles published in the journal assign copyright to Cambridge University Press (with certain rights reserved) and you will receive a copyright assignment form for signature on acceptance of your paper.

Acceptance of submitted material is on the understanding that it will not be reproduced in full or in part without the permission of the publishers. However, reasonable requests to reproduce figures appearing in Reviews in Clinical Gerontology will be considered favourably, subject to due recognition. If you are in doubt about whether or not permission is required, please consult Cambridge University Press.

PROOFS

Proofs will be supplied only once in the form of page proofs. Please remember that:

(i) Proof corrections are disproportionately expensive. For example, the insertion of three commas on a page will frequently cost as much as, or more than, the original setting cost of the entire page.

(ii) If you return proofs even a few days after the date stipulated, it may be too late to include your corrections in the final version of the journal.

The publisher reserves the right to charge authors for corrections of non-typographical errors.

OFFPRINTS

Each principal author will receive 25 offprints of his/her review. Additional offprints can be purchased if ordered at proof stage.
