References: Footnotes, numbered, continuously. No bibliography at the end.

To books: first name, initial(s) and last name author(s), title (italic), edition,

year, page number

**Subsequent references**: last name, title (abbreviated), page number

To edited volumes: same as with books, but with (ed.) or (eds.) after the last

## To papers in edited volumes:

Subsequent references: Last name, title paper (abbreviated), page number

Spence, 'The Complexity of Success in Russia', at p.221.

<u>To journal articles</u>: First name, initial(s), last name, title article, in: volume, journal title (italics), year (in brackets), first page of article, page to which is being referred.

Amanda J. Perry, 'The Relationship between Legal Systems and Economic Development: Integrating Economic and Cultural Approaches', in: 29 *Journal of Law and Society* (2002), p. 282, at p. 300.

Subsequent references: as with books, but only (abbreviated) title of paper

Perry, 'The Relationship between Legal Systems and Economic Development', at p. 300.

**<u>Legislation, case-law etc:</u>** use the appropriate standard

Website: address plus date last accessed in brackets.

Quotations: Quotations are to be placed between single quotation marks, both in the text

and in the footnotes.

It is a rule of thumb that quotations longer than four lines are to be typed as a block. When a quotation forms part of another quotation, it is to be placed

between double quotation marks.

Figures: Charges apply for all colour figures that appear in the print version of the

journal. At the time of submission, contributors should clearly state whether their figures should appear in colour in the online version only, or whether they should appear in colour online and in the print version. There is no charge for including colour figures in the online version of the Journal but it must be clear that colour is needed to enhance the meaning of the figure, rather than simply being for aesthetic purposes. If you request colour figures in the printed version, you will be contacted by CCC-Rightslink who are acting on our behalf to collect Author Charges. Please follow their instructions in order to avoid any delay in

the publication of your article.
