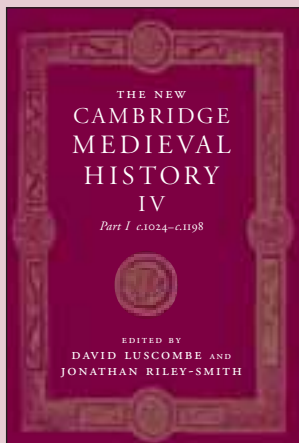

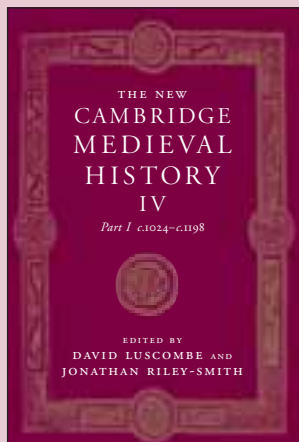

This, the second of two parts, deals with the course of events – ecclesiastical and secular – with regard to the papacy, the western empire (mainly Germany), Italy, France, Spain, the British Isles, Scandinavia, Hungary, Poland, the Byzantine empire, the settlements in Palestine and Syria established by the crusades and their Muslim neighbours. It also looks at the major developments in an age marked by the transformation of the role of the papacy – a process fuelled by a radical reformation of the church, the decline of the western and eastern empires, the rise of western kingdoms and Italian elites, and the development of governmental structures, the beginnings of the recovery of Spain from the Moors and the establishment of western settlements in the eastern Mediterranean region in the wake of the crusades.

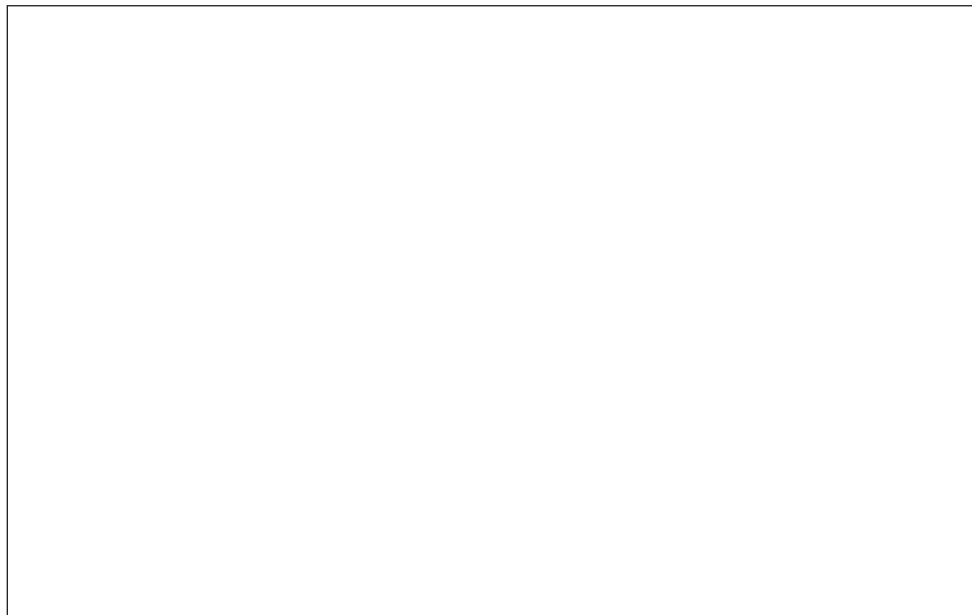
