LAMAR CECIL was born in Texas in 1932. He completed his Ph.D. under the supervision of Hans W. Gatzke at Johns Hopkins University in 1962 and is now Professor of History at the University of North Carolina at Chapel Hill. His publications include *Albert Ballin: Business and Politics in Imperial Germany, 1888–1918* (Princeton, 1967; German edition 1969) and *The German Diplomatic Service 1871–1914* (Princeton, 1976). He is currently writing a biography of Kaiser Wilhelm II.

TERRY COLE was born in Wiltshire in 1944. He studied Philosophy and History in the School of European Studies at the University of Sussex and is now Lecturer in History at the University of Edinburgh. He is writing a biography of Reich Chancellor Bernhard von Bülow.

WILHELM DEIST was born in Stuttgart in 1931. He is now Academic Director of the Militärgeschichtliches Forschungsamt in Freiburg and co-editor of the *Militärgeschichtliche Mitteilungen* and of the *War and Society Newsletter*. His many publications include *Militär und Innenpolitik im Weltkrieg, 1914–1918* (Düsseldorf, 1970); *Flottenpolitik und Flottenpropaganda: Das Nachrichtenbureau des Reichsmarineamts, 1897–1914* (Stuttgart, 1976); and *The Wehrmacht and German Rearmament* (London, 1981). In 1978 he was Visiting Leverhulme Fellow at St Antony's College, Oxford.

ELISABETH FEHRENBACH was born in Düsseldorf in 1937. She completed her doctorate under the supervision of Theodor Schieder at Cologne University in 1967 and is now Professor of History at the University of the Saarland in Saarbrücken. Her books include *Wandlungen des deutschen Kaisergedankens, 1871–1918* (Munich, 1969) and *Traditionelle Gesellschaft und revolutionäres Recht: Die Einführung des Code Napoléon in den Rheinbundstaaten* (Göttingen, 1974).

ISABEL V. HULL was born in 1949. She received her B.A. at the University of Michigan in 1970 with Highest Honours in History,

and went on to do her Ph.D. with Hans W. Gatzke at Yale University. Her study of the entourage of Kaiser Wilhelm II, 1888–1918, is shortly to be published by Cambridge University Press. She is now working on a history of sexual morality in Imperial Germany.

PAUL KENNEDY was born in 1945 in Northumberland. He was educated at the University of Newcastle, where he took a First in History before moving to Oxford to complete his D.Phil. in 1970. At present he is Reader in History at the University of East Anglia. His numerous publications include the following works: *The Samoan Tangle: A Study of Anglo-German-American Relations, 1878–1900* (Dublin and New York, 1974); *The Rise and Fall of British Naval Mastery* (London and New York, 1976); *The Rise of the Anglo-German Antagonism, 1860–1914* (London and New York, 1980); and *The Realities behind Diplomacy: Background Influences on British External Policy, 1865–1980* (London, 1981).

THOMAS A. KOHUT is writing a doctoral dissertation under the supervision of Otto Pflanze at the University of Minnesota on the psychology of Kaiser Wilhelm II. He was born in Chicago in 1950 and was educated at Oberlin College and the University of Minnesota. Since 1977 he has also been a research candidate at the Cincinnati Psychoanalytic Institute.

KATHY LERMAN was born in Hertfordshire in 1954. She studied History in the School of European Studies at the University of Sussex, where she took a First. She is now Lecturer in Modern European History at St David's University College, Lampeter, Wales, and is completing a doctoral dissertation on the German government system during the Chancellorship of Bernhard von Bülow, 1900–9.

JOHN C. G. RÖHL was born in London in 1938. He received a First in both parts of the Historical Tripos at Corpus Christi College, Cambridge, and went on to complete his Ph.D. under the guidance of F. H. Hinsley in 1965. He has been teaching History in the School of European Studies at the University of Sussex since 1964; he was promoted to a Chair there in 1979. His publications include *Germany without Bismarck: The Crisis of Government in the Second Reich, 1890–1900* (London and Berkeley, 1967; German edition 1969); *From Bismarck to Hitler: The Problem of Continuity in German History* (London and New York, 1970); *1914 – Delusion or Design? Philipp Eulenburgs politische Korrespondenz, 3 volumes (Boppard-am-Rhein, 1976–83). He has now begun work on a biography of Kaiser Wilhelm II.

NICOLAUS SOMBART was born in 1923. After studying in Heidelberg, Naples and Paris he took his Dr.Phil. with Alfred Weber in Heidelberg in 1952 before becoming an international civil servant with the Council of Europe in Strassburg, where he is now Head of the Department of Cultural Affairs. He has lectured as a visiting professor at the Universities of Ulm, Freiburg and Wuppertal, and is the author of numerous publications. His special interest in Wilhelmine society stems from his family background: his grandfather was a member of the Reichstag and Prussian Landtag, and his father Werner Sombart (1863–1941) a Prussian professor. He is currently working on a book on political thought and sexuality in Germany, and on a major essay on Wilhelm II.

JONATHAN STEINBERG was born in New York in 1934. He took his B.A. at Harvard in 1955 and his Ph.D. under the supervision of F. H. Hinsley at Cambridge University ten years later. Since 1966 he has been University Lecturer and Fellow and Tutor at Trinity Hall, Cambridge. His publications include *Yesterday's Deterrent: Tirpitz and the Birth of the German Battle Fleet* (London and New York, 1965; Italian edition 1970); and *Why Switzerland?* (Cambridge, 1976).
