A NOTE ON SPELLING

A consistency in the spelling of Indian names which would not be false or deceptive is difficult to achieve. For instance, over the last hundred years the accepted spellings of most place names have changed, e.g. Cawnpore has become Cawnpur and then Kanpur, while at any one time proper names have been spelled in several different ways, e.g. Mahomed, Mohammad, Mohammed, Muhammad etc....To impose a comprehensive system on the names used would undoubtedly bring greater phonetic and linguistic precision but it would be at the cost, first of making some names almost unrecognisable to the reader, and second of eliminating differences in the English spellings of proper names which Indians were themselves concerned to perpetuate, e.g. one man would spell his name Ahmad or Husain, another Ahmed or Hussain, and such differences have become an accepted part of Indian life – there are for instance twenty-four different spellings of the name Choudhri in the most recent edition of the Delhi telephone directory. The plan which has been adopted in this book, therefore, has been to spell place names according to the District Gazetteers of the United Provinces of Agra and Oudh of 1903-11, and proper names as they were most commonly spelled during the period.
