 (Photograph by the Rev. J. E. Gethyn-Jones.)
 E. W. Tristram, *English Medieval Wall Painting: the Twelfth Century* (Oxford, 1944), pp. 42–4, 134–6, dates this wall-painting c. 1150. The bishop has no halo, so can hardly be intended for a saint. Kempley was in the diocese of Hereford, and had a link with St Guthlac's priory (*Taxatio*, p. 161). Gilbert Foliot is thus a possible candidate. But the date is far from certain, and Mr Gethyn-Jones tells us that there are grounds for an earlier date (possibly c. 1120; see his *St Mary's Church, Kempley, and its paintings*, 1 (1961), pp. 13, 65; a fuller study will appear in vol. II).

PREFACE

Early in 1940 Dom Adrian Morey wrote to Z. N. Brooke to say that he was thinking of undertaking an edition of the letters of Gilbert Foliot. Dr Brooke replied that he had had the same idea—each had conceived it as an effort to refresh his mind in his scanty leisure—and a collaboration was happily arranged. The chief manuscripts were not available until 1945, so that work moved slowly for some years. In 1945–6 serious work on the texts was begun; but in October 1946 the senior editor died. Since then the work has been continued by Dom Adrian Morey and C. N. L. Brooke. Dom Morey has been helped on by two years' freedom from administrative duties in 1950–2; C. N. L. Brooke by some years as a Research Fellow in Gonville and Caius College and by a term's leave of absence in the University of Liverpool. Both have been held back by many other calls on their time and by much other work. Z. N. Brooke and Dom Morey had made some progress with the letters before the former's death, and had begun to collect a list of charters, although it was only some years later that a definite decision was made to include them. The main manuscript of the letters, Bodleian E Musaeo 249, includes a substantial number of charters, and so we had the choice of presenting these alone or adding charters from other sources; since the interest of a considerable number of the letters lies in diocesan administration, and the number of surviving charters of Gilbert Foliot is quite exceptional for a diocesan bishop of this period, there seemed little doubt that the right course was to include all the available charters. For the most part the study of the manuscripts, detailed notes on people and events referred to in the letters and charters, and other notes necessary for an edition are in this book; a fuller commentary on a few especially interesting letters, and a study of Gilbert Foliot and his milieu, are contained in a companion volume, *Gilbert Foliot and His Letters*. We have tried to reduce to the minimum repetition between the volumes, and to include fairly copious cross-references. This has led to some divisions of function: thus notes on most of the people who figure prominently in the letters are contained in the Biographical Index to this volume, but those on men who were members of the chapter of Hereford or St Paul's or clerks in Gilbert Foliot's household are contained in appendix iv of *Gilbert Foliot and His Letters*.

Nearly twenty years have passed since the death of Z. N. Brooke, but his help and inspiration have been in our minds throughout, and his own work and notes were of direct use in many parts of this book; Mrs Brooke lived to know that the book was virtually completed and to give us much encouragement, though it is our special regret that she did not see it in print. Our warm thanks are also due to Professor David Knowles, for constant encouragement and guidance, to Dr Rosalind Brooke for equally constant help and encouragement, to the late Professor W. Holtzmann for generously providing much of the material used in appendix viii, to Professor and Mrs C. R. Cheney for references to and transcripts of a number of
