Note on references

Most references to major primary printed sources are given in the text. For Tyrrell, bibliographical details of books can be found with the abbreviations. I have not listed all other references to Tyrrell's works in the bibliography, as the relevant references are given in the notes at the end of each chapter, and the general selection is inevitably eclectic. Thomas Loome's bibliography (The Heythrop Journal, 10 (1969), 280-314; 11 (1970), 161-9; Liberal Catholicism, Reform Catholicism, Modernism (Mainz, 1979), pp. 218-27), and that of David Schultenover, George Tyrrell (Shepherdstown, USA, 1981), pp. 434-62, can be confidently used for further information. The whereabouts of letters can be discovered from the list of unpublished sources in the bibliography. Where I have used printed sources for letters, these are given in the text or notes. For Arnold's prose I have used the Michigan edition of The Complete Prose Works of Matthew Arnold, edited by R. H. Super. This is referred to by an 'S', followed by the volume number, an indication of Arnold's original title where appropriate, and the page number. For his poetry I have used The Poems of Matthew Arnold, edited by Kenneth Allott, second edition, edited by Miriam Allott, in the Longman Annotated English Poets series (London, 1979).
