ACKNOWLEDGEMENTS

In the fall of 1964 I finished work on a doctoral dissertation which bore the pretentious name, 'The Economic Development of Colombia'. In the interim I have sought to correct some of the weaknesses of that work and have as a consequence found myself doing a new and very different book, different that is from the earlier effort and its concentration on the past as a simple prologue to current problems of economic development in Colombia – and by extension in the less developed countries. In the course of changing directions and emphasis I amassed an impressive collection of intellectual debts which I am most happy to acknowledge.

The early supervisors of my work of course bear no responsibility for the current product, but if there is merit in this work it owes much to their guidance. Everett E. Hagen, Charles P. A number of friends read earlier drafts of the manuscript and made valuable comments. These include D. A. Brading, Woodrow Borah, Albert Fishlow, Herbert Klein and James Parsons. Their kindnesses have at times been above and beyond the call of collegial duty.

The numerous calculations and quantitative investigations which were carried out as part of the research for this book could never have been accomplished without the assistance of a number of able graduate students at the University of California. These include Harry Cross, Eul Soo Pang, David C. Johnson, Michael Conniff and Jorge Rodriguez. The last mentioned were particularly helpful in the preparation of land use estimates and the revised estimates of Colombian foreign trade.
