



EDITOR'S PREFACE

Sir Hersch Lauterpacht's academic writings include five major monographs, of which two later appeared in much expanded revisions; four courses of lectures at the Hague Academy of International Law; over sixty articles; and two Reports on the Law of Treaties prepared for the International Law Commission. He prepared four editions of volume I, and three editions of volume II, of Oppenheim's *International Law*. He also edited Part III of the *Manual of Military Law*, containing 'The Law of War on Land'. This list leaves aside book reviews and notes, many of which it is difficult or impossible to trace. In addition, he wrote numerous unpublished memoranda and opinions. Finally, as a Judge of the International Court of Justice, he produced four Separate Opinions, two Dissenting Opinions, and a Declaration.

Although Lauterpacht's writing covered the full range of public international law, he never published a comprehensive treatise of his own. On looking at his work as a whole—and being anxious, in presenting his collected papers, to construct from them something which would serve both as a memorial to their author and as a work of lasting value to other international lawyers—it seemed to me that if the writings were assembled in a systematic form they might well stand as a substitute for the treatise that was never written. Each item has therefore been printed as if it were a chapter or a section of a comprehensive work covering the traditional divisions of international law—peace, disputes, war and neutrality. My hope is that, presented in this way, the whole will be greater than the sum of its parts.

The scheme which I have followed is based upon drafts (found amongst Lauterpacht's papers) of an outline of the textbook which he intended writing—though it has been necessary, of course, to make some adjustments to accommodate the available material. The contents of these volumes are, therefore, now divided into the following principal parts: 'International Law in General', covering the nature, history, sources and subjects of international law, as well as the relationship of international law and municipal law; 'States as Subjects of International Law', comprising recognition, State succession and jurisdiction; 'State Territory'; 'The Individual in International Law'; 'The Law of Treaties'; 'Organs of International Government'; 'The International Court of Justice'; 'Renunciation of Force'; and 'War and Neutrality'.

EDITOR'S PREFACE

However, the collection begins, in this first volume, not with the material falling within the classification just described, but with three more general works—the newly written ‘General Part’ prepared for a ninth edition of Oppenheim that Lauterpacht never completed, an English text of the ‘general’ course of lectures delivered in French at the Hague Academy in 1937 and the *Survey of International Law in relation to the Work of Codification of the International Law Commission*, written for the United Nations in 1948. Their publication as the introductory volume of this collection requires no justification. A more detailed editorial note is printed before each of these items.

The contents of these volumes are limited to Lauterpacht’s articles, published courses of lectures, reports and judgments. Within these categories, the collection is as complete as I can make it—save for various articles which were subsequently reprinted, almost unchanged in content, in some of his monographs. The subject principally affected is ‘Recognition’. Between 1939 and 1945, Lauterpacht published a number of articles on various topics of Recognition which were then incorporated in his book on *Recognition in International Law* published in 1947. The same is true of some, though not all, of his works on human rights. The essential substance of the lectures given at the Hague Academy in 1947 and the Report on the subject presented to the International Law Association in 1948 reappear in the volume entitled *International Law and Human Rights* published in 1950. On the other hand, some of his earlier articles and lectures, for example on the doctrine of non-justiciable disputes, are included, though their content is largely reflected in his work on *The Function of Law in the International Community* (1933).

It has not been easy to reach the decision to exclude the articles mentioned above. The argument in favour of the complete presentation of all Lauterpacht’s articles within these volumes is a cogent one. At the same time, the bulk of these Collected Papers already runs large without these articles; and the total size of the publication must be kept within reasonable limits. Moreover, *Recognition in International Law* is likely to be reprinted in the not too distant future with notes and comments bringing it up to date; and *International Law and Human Rights* has already been reprinted.

Also omitted from these volumes are book reviews—principally because, as comments upon the work of others, they do not properly belong in a work which is presented essentially as an exposition of the law. Nor have I been able to include all his occasional papers. Where

there exists a reasonably polished text, I have used it; but where there exist only rough notes or unrevised drafts, I have felt it best to omit these. Opinions written in a professional capacity have, with rare exceptions, also been excluded, largely because it has not been possible to secure the consent necessary for their publication.

Edited by anyone else than his son, these papers should no doubt have been introduced by some account of Lauterpacht's life and some over-all consideration of his work. But I am not the person to comment upon his work nor yet to write about his life. In any case, both tasks have already been carried out by the most qualified hands. To mention but some, Dr Jenks has written about Lauterpacht's contribution to international law in volumes **xxxvi**, **xxxvii** and **xxxviii** of the *British Year Book of International Law*, as have Dr Rosenne, Judge Jessup and Professor Baxter in volume **lv** of the *American Journal of International Law*; while Lord McNair and Sir Gerald Fitzmaurice have written about his life in the *Proceedings of the British Academy*, volume **xlvi**, p. 371, and in *Graya*, the journal of Gray's Inn.

In planning this collection, I have had the great advantage of being able to turn for general guidance and help to a number of Hersch Lauterpacht's close friends: Lord McNair, Sir Gerald Fitzmaurice, Dr C. W. Jenks and Professor R. Y. Jennings. They are, of course, not responsible for what I have done; nor would they necessarily agree in every detail with my selection of items. But they have approved of the general scheme and have provided me with stimulus and encouragement, for which I am deeply grateful. In the actual execution of the work I have had important assistance from Dr Gillian White, Miss M. MacGlashan, Mrs A. B. Lyons, Mrs C. J. French, Miss A. Munkman, Miss E. Gawler, Mrs E. E. Jansen and Mrs S. Rainbow—to whom I express my warmest thanks. The personnel of the Cambridge University Press have tolerated the numerous delays which have beset the delivery of copy and the return of proofs with a tolerance and patience for which I remain much beholden. And last, but by no means least, I must say a word to acknowledge the loving concern which Hersch Lauterpacht's widow, my mother, Rachel Lauterpacht, has shown at every stage of the evolution of this work.
