

PREFACE

As a further step in the presentation of Hersch Lauterpacht's works in systematic form, this volume moves on from Part I, 'International Law in General', to cover a further five Parts falling within the Law of Peace : statehood ; territory and territorial jurisdiction ; the individual ; diplomatic intercourse ; and international organization. The fuller titles given to these Parts within the volume correspond with Lauterpacht's own outline.

The volume contains a greater number of Lauterpacht's previously unpublished writings than did the previous volume and will, for that reason, be of special value and interest. Attention may, in particular, be called to the remarkable study of the principles of international organization written, it would appear, some time in 1942-3, which is printed as chapter 1 of Part VI; to the lectures on 'Sovereignty and federation in international law' (Part II, chapter 1), 'State sovereignty and human rights' (Part IV, chapter 4), and 'The League of Nations' (Part VI, chapter 5), all of which, though prepared thirty-five and forty-three years ago respectively, possess a striking degree of contemporary relevance ; to four professional opinions of considerable historical significance and, not least, to the dissertation on the Mandates system which Lauterpacht submitted to the University of Vienna in 1922.

It has proved necessary to depart from Lauterpacht's scheme in one respect. The original classification placed 'The Contractual Relations of States : Treaties' after 'State Territory' and before 'The Individual in International Law'. However, because the material on treaties is too great to fit as an undivided Part into its proper place within this volume, it seems better, in the interests of a clearer presentation of this material, to postpone it to the next volume and to advance certain topics which would otherwise have followed it.

This volume contains within the relevant sections one declaration and two separate opinions which Lauterpacht delivered as a judge of the International Court of Justice. His other separate opinions will appear, as appropriate, later. It has not always been easy to classify the separate opinions for, as hardly needs saying, each opinion touches upon a number of topics. The opinions have, therefore, been introduced at the points justified by their principal content. This decision was reached after correspondence with the late Lord McNair, the late Dr C. W. Jenks, Sir Gerald Fitzmaurice, Ambassador Shabtai Rosenne, Professor R. Y. Jennings, Professor R. R. Baxter and Professor S. M. Schwebel,

during which two other ways of presenting the judicial materials were considered and finally rejected: one being to publish all the judicial opinions together in a separate volume and the other to divide up each opinion and print its component parts at the appropriate places within the classification.

Those whose names I have just mentioned have given me counsel on many other points connected with these volumes. It is a source of great sorrow to me that I can no longer turn to Lord McNair or to Wilfred Jenks. They were two of my father's closest friends and both of them had shown me, for as long as I could recollect, warm understanding and generous help for which I shall ever remain grateful.

It is fitting, too, that I should recall with deep appreciation the name of the late Mrs Gladys Lyons, B.Sc. (Econ.), who devoted to many of the papers in this volume the same degree of conscientious skill which she showed for more than forty years in relation to so much of my father's other work.

I am most grateful to those who have given their consent to the publication of the various papers. As to hitherto unpublished texts, Part II, chapters 3 and 4, and Part VI, chapter 2 are printed with the permission of the Zionist Archives and Part V, chapter 1 with that of the Swiss Federal Political Department. Permission to reprint the other chapters has been given by the following: the American Society of International Law – Part III, chapter 7; the British Broadcasting Corporation – Part IV, chapter 3; the British Institute of International and Comparative Law – Part III, chapter 8; the Editor of the *Cambridge Law Journal* – Part III, chapters 4 and 6; the International Court of Justice – Part III, chapter 2 and Part VI, chapters 3 and 4; the Editor of the *Jewish Yearbook of International Law* – Part IV, chapter 1; Oxford University Press – Part III, chapters 1, 9 and 10 and Part VI, chapter 6; the Editor of *The Political Quarterly* – Part VI, chapter 7; the Times Publishing Company Ltd – Part II, chapter 5, Part III, chapters 3 and 5 and Part IV, chapter 2.

Ambassador Rosenne, in addition to his advice regarding the judicial materials, assisted me greatly in tracing the opinions which were given to the Jewish Agency.
