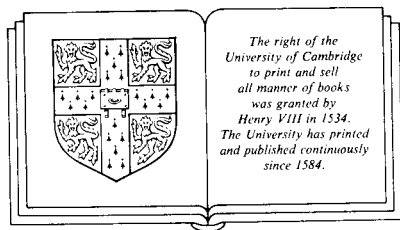

JONATHAN ARAC is Professor in the Program of Literature at Duke University. Author of *Commissioned Spirits* (1979) and *Critical Genealogies* (Columbia University Press, forthcoming), he has coedited *The Yale Critics* (1983) and *Postmodernism and Politics* (1986). Currently his work focuses on nineteenth-century American prose narrative.

CATHERINE BELSEY is Lecturer in English at University College, Cardiff. She is the author of *Critical Practice* (1980) and *The Subject of Tragedy* (1985). Her main interests are in Renaissance drama and poetry, critical theory and feminist studies. At present she is writing a short book on Milton for Blackwell's "Re-Reading Literature" series.

HAROLD BLOOM is Professor of English at Yale University. He is the author of numerous books and articles on aspects of Romantic and post-Romantic poetry. His work has been highly controversial, partly through its strong revisionist reading of this canon, and partly through Bloom's radically antinomian concepts of poetic influence, authority and tradition.

STEPHEN BYGRAVE is currently Lecturer in English at the University of Leeds. He has written on various topics in the fields of critical theory, nineteenth-century aesthetics and the history of ideas. Macmillan have recently published his book, *Coleridge and the Self: Romantic egotism*. At present he is at work on several projects, including a study of Kenneth Burke for the Croom Helm series "Critics Of The Twentieth Century".

THOMAS DOCHERTY teaches English at Corpus Christi College, Oxford. His *Reading (Absent) Character* was published in 1983 by Oxford University Press; *On Modern Authority: the condition of writing from 1500 to the present* is forthcoming from Harvester. His essay in this volume is from work-in-progress toward a study of Donne, to be published by Methuen. His other main interest at present is in "postmodern" theory and culture, especially as related to the various "modernisms" in Europe from the Renaissance to the twentieth century.

JOHN DRAKAKIS is Lecturer in English Studies at the University of Stirling. He has published books on *Othello* and *Much Ado about Nothing*; has edited volumes of essays on Shakespeare and British radio drama; and is General Editor of a new series, "Methuen English Texts", commencing publication in 1986. He has written widely on Elizabethan and Jacobean drama, and is currently preparing a new edition of Marlowe's *Doctor Faustus*.

ANTONY EASTHOPE teaches English and Cultural Studies at Manchester Polytechnic. In addition to *Poetry as Discourse* (1983) his published work includes *The Masculine Myth*, a study of representations of masculinity in popular culture. His latest book *Poetry and Phantasy* – on aspects of psychoanalysis and ideological critique – should be published during 1986. At present he is writing a critical survey of developments in British post-structuralist theory.

MAUD ELLMANN is Lecturer in English at the University of Southampton. She has also taught and lectured at various North American universities. Her publications include essays from a feminist and post-structuralist standpoint on a wide range of authors, from Chaucer to T. S. Eliot and Joyce. She is closely involved with the journal *Oxford Literary Review*, and has recently completed a book entitled *Modernist Writing and the Problem of the Subject*, soon to be published by Harvester.

FRANCES FERGUSON is Professor of English at the University of California, Berkeley. She has published widely on various aspects of romantic poetry, and her book *Wordsworth: language as counter-spirit* appeared from Yale University Press in 1977. At present she is completing a study of education and its ideological dimensions in the eighteenth and nineteenth centuries.

JONATHAN GOLDBERG is Professor of English at John Hopkins University, Baltimore. He is the author of *Endlesse Worke: Spenser and the structures of discourse* (1981), *James I and the Politics Of Literature* (1983) and *Voice Terminal Echo: postmodernism and English Renaissance texts* (1986). He is currently engaged in research on Shakespeare and cultural graphology.

GEOFFREY HARTMAN is Professor of English and Comparative Literature at Yale University. His many published works include books on Wordsworth, on Derrida (*Saving the Text*, 1981) and on

various issues in present-day cultural and critical theory. Since the essays collected in *Beyond Formalism* (1971), it has always been his aim to broaden the scope and enliven the style of literary criticism, drawing on Continental sources (from Hegel to Benjamin and Derrida) as a means of resisting the “teetotal” ethos of the dominant Anglo-American tradition. His most recent book, *Easy Pieces* (1985), sets out to present these issues at a somewhat more accessible level of debate.

ROB JOHNSON is a Reader in English at the University of Adelaide. His publications include *Walter Pater as Critic* (1981), *Aestheticism* (1969) and a volume of poems, *Caught on the Hop* (1984). He hopes to publish a second collection within the next year. His current main interests – in Victorian poetry and critical theory – reflect his belief that these new ways of reading are at once more adventurous and more subtly responsive than traditional approaches.

MURRAY KRIEGER is University Professor of English at the University of California, Irvine. He was the founding Director, and is presently an Honorary Senior Fellow, of the School of Criticism and Theory. The author of many books, among them, most recently, *Theory of Criticism, Poetic Presence and Illusion* and *Arts on the Level*, he is currently at work on *Ekphrasis: space, time and illusion in literary theory*.

RICHARD MACHIN has written on various topics in modern criticism and literary theory. At present he is completing a book on Paul de Man, to be published by Croom Helm in 1987. His other interests extend to Artificial Intelligence, machine translation and the history of science in its textual or rhetorical aspects. He taught for two years in the Department of English at UWIST, Cardiff, before taking up his present work in the field of computer research.

WALLACE MARTIN teaches at the University of Toledo (Ohio). His essays on critical theory have appeared in *Comparative Literature*, *Critical Inquiry*, and *Diacritics*. He is the author of “*The New Age*” under Orage: *chapters in English cultural history* and coeditor (with Jonathan Arac and Wlad Godzich) of *The Yale Critics: deconstruction in America*. His latest book *Recent Theories of Narrative* was published by Cornell University Press in 1985.

J. HILLIS MILLER is Frederick W. Hilles Professor of English and Comparative Literature at Yale University. He has published many

books and articles on nineteenth- and twentieth-century English and American literature. Most recent of these are *Fiction and Repetition: seven English novels* (1983) and *The Linguistic Moment: from Wordsworth to Stevens* (1985). He is currently at work on a book whose main concern is the ethics of reading.

CHRISTOPHER NORRIS is Reader in English at the University of Wales in Cardiff. His books include *William Empson* (1978), *Deconstruction: theory and practice* (1982), *The Deconstructive Turn* (1983) and *The Contest of Faculties* (1985). He has also published widely in British and American literary journals, and has edited two volumes of essays, on Shostakovich (1982) and George Orwell (1984). At present he is writing a book on Jacques Derrida for the “Modern Masters” series.

DANIEL T. O’HARA is Professor of English at Temple University, Philadelphia. An editor of the journal *boundary 2*, he is also the author of two books from Columbia University Press: *Tragic Knowledge: Yeats’s autobiography and hermeneutics* (1981) and *The Romance of Interpretation: visionary criticism from Pater to de Man* (1985). In addition, he has published many essays on nineteenth- and twentieth-century literature and has edited two collections of essays on critical theory. He is currently completing a book on Lionel Trilling and American culture during the Cold War period.

RICHARD RAND is currently a Visiting Professor of English at Trinity College, Hartford, Connecticut. He has contributed essays to various journals and anthologies of criticism, mainly on English Romantic poetry. His translation of Derrida’s *Signéponge/Signsponge* was published by Columbia University Press in 1984, and he is now at work (with John P. Leavey) on the yet more extraordinary task of Englishing Derrida’s *Glas*.

GAYATRI CHAKRAVORTY SPIVAK is Longstreet Professor of English, Emory University, Atlanta, Georgia, having lectured widely and taught at several American universities during the past few years. She has written numerous articles on feminism, politics and critical theory, and is known as one of the chief exponents of “left” deconstruction in America. In 1977 Johns Hopkins published her elaborately annotated translation of Derrida’s *Of Grammatology*, probably the single most influential text in recent critical debate. Her main interests at present are in the uses of deconstruction as a means to resist various forms of racial, political and sexual oppression.
