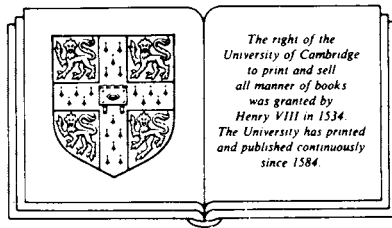

His philosophical articles address issues of metaphysics, ethics, and biophilosophy as well as classical themes in the history of philosophy, especially those of the Jewish and Islamic thinkers who

Her book *Emotions and Reasons: An Inquiry into Emotional Justifications* is scheduled to be published by Routledge and Kegan Paul. Her influential papers include "Behavior Control and Freedom of Action" and "Conditional Oughts and Hypothetical Imperatives."

NILS JAREBORG is professor of criminal law and dean of faculty at Uppsala University, Sweden. He has authored fifteen books and numerous articles in criminal law and jurisprudence. He serves on several legislative committees. Current projects include work on the seriousness of crime, with Andrew von Hirsch.

HERBERT MORRIS is professor of philosophy and of law and dean of humanities at the University of California at Los Angeles. His interests include moral and legal philosophy and moral psychology. His influential papers include "Persons and Punishment," "Guilt and Suffering," "A Paternalistic Theory of Punishment," and "Punishment for Thoughts." He is editor of the volume *Freedom and Responsibility*, as well as of other collections.

MICHAEL S. MOORE holds a joint appointment in law at the University of California at Berkeley and at the University of Southern California, where he is the Robert Kingsley Professor of Law. He is the author of *Law and Psychiatry: Rethinking the Relationship* and has written papers on responsibility that have appeared in legal, philosophical, psychological, and psychiatric journals. He is currently working on a book on legal reasoning that will appear in the Clarendon Law Series of Oxford University Press.

JOHN SABINI is associate professor of psychology at the University of Pennsylvania. His interests are in understanding emotions and judgments of character. Along with Maury Silver, he is the author of *Moralities of Everyday Life*, and he is coeditor (with Michael Frese) of *Goal Directed Behavior*.

FERDINAND SCHOEMAN is professor of philosophy at the University of South Carolina. He is the editor of *Philosophical Dimensions of Privacy*, and is currently working on a book on privacy. His research interests include moral psychology and the limits of moral reasoning.
