

Taking as their point of departure general theoretical debates in the theory of ethnicity, the authors of this book present a wide-ranging and up-to-date analysis of the characteristics and interrelationships of ethnicity, religion, and class in Israeli society. While much has been written about the basic division between Jews from Europe and from North Africa and Asia, this book puts forward a more nuanced survey than the rather crude division which has formed the basis of most works on the subject. By focusing on four groups of Jewish origin in Israel (from Morocco, Iraq, Poland, and Rumania), and by including from each group both white- and blue-collar workers, the authors demonstrate the importance of breaking down simplistic categories of ethnicity. The work thus takes much further the analysis of ethnic identities and relations in Israeli society, and the data acquired from a rich ethnic mix lead to the analysis of a wide range of theoretical issues, which casts fresh light on social cleavages within Israel in particular and society in general.


