This volume brings together a wide-ranging collection of papers by Jeremy Waldron, one of the most internationally respected political theorists writing today.

The main focus of the collection is on the idea of rights, as it features in substantive debates in modern political philosophy. The first six chapters deal with freedom, toleration, and neutrality. Waldron defends the robust liberal principle that people have a right to act in ways that others disapprove of, even where their activities offend cherished beliefs or the norms of their community. The chapters that follow are concerned with socioeconomic rights. Waldron argues that poverty and homelessness, as much as intolerance or oppression, are affronts to individual liberty. The liberal ideal is that people are entitled to live life on their own terms. That ideal is undermined, not served, when the interest of some people in power, luxury, or comfort has the effect of excluding others forcibly from the resources they need to live.

The collection will be of particular interest to political philosophers, political scientists, and legal theorists.
