## EDITORIAL NOTE

This series of *Reports* contains the texts of Decisions, Awards, Awards on Agreed Terms, Interim Awards, Interlocutory Awards, Interim and Interlocutory Awards, Refusal Cases and Selected Orders emanating from the Iran—U.S. Claims Tribunal set up under the Claims Settlement Declaration to which the Governments of Iran and the United States adhered on 19 January 1981.

The present volume contains material dated during the period 10 January 1985 to 12 August 1985 but often not made available until later.

*Decisions* are rendered by the Tribunal in cases arising directly between the Governments of Iran and the United States.

*Awards* are rendered in respect of claims by individual claimants, as are *Interim Awards*, *Interlocutory Awards*, *Interim and Interlocutory Awards* and *Awards on Agreed Terms*.

The texts of the Settlement Agreements on the basis of which *Awards on Agreed Terms* are rendered have in some cases been omitted, either because the Tribunal has agreed that they should be kept confidential or because many Settlement Agreements appear to follow a standard form though varying according to the subject matter of the claim, and in some cases the content of the Settlement Agreement is reproduced extensively in the *Award*. Where a Settlement Agreement is not in a standard form or otherwise seems to contain provisions which may have wider legal significance it is printed in the appropriate place. Purely formal documents (such as powers of attorney) annexed to *Awards on Agreed Terms* are omitted.

*Selected Orders* are selected from the many hundreds of interlocutory orders which the Tribunal or its Chambers make at various stages of the proceedings.

All known *Decisions* and *Awards* are printed in these *Reports*. To the extent that they are made public all *Awards on Agreed Terms* are printed, as is true also of *Refusal Cases*. The choice of *Selected Orders* has been made on the basis of availability to the *Reports* and has been further limited by the exclusion of those which appear to be of only limited or transient significance.

Careful consideration has been given to the question of the extent to which it would be appropriate to edit the texts issued by the Tribunal. The conclusion has been reached that it would be better if no changes were made, even though this means that texts which appear here may occasionally look as if there have been lapses in printing. The reader is assured that special care has been taken in checking the proof.

The materials are printed in chronological order—on the basis of the dates on which they were signed. In some cases, dissenting or separate opinions have been filed by one or more Members of the Tribunal after the date of signature of the *Decision, Award or Order*; and in other cases, a separate or dissenting opinion may relate to more than one claim. In such situations, the order of appearance of the dissenting or separate opinion is regulated by the date of the signature it bears. The absence of a dissenting opinion of which the existence is in some way indicated in the printed texts means only that the document has not yet been released.

Editorial footnotes are identified by the enclosure within square brackets of both the footnote indicator and the footnote itself. All other footnotes are printed as they appear in the original texts.

The Index is limited to matters dealt with in the argument of the Tribunal or Chamber in each *Decision* or *Award* or in the separate, concurring or dissenting opinions of individual Members, and does not cover matters appearing in the facts or in the arguments of the parties.

The Index and Tables of Cases of the present volume have been consolidated with those of the earlier volumes. There is also a separate Table of Cases for cases in this volume.

If further material dated within the period covered by this volume should become available after the publication of this volume, it will be printed in a later volume of the *Reports*.
