In this book, leading western specialists and Russian and Ukrainian feminists examine how gender has shaped Russian and Ukrainian history from the twelfth century to the present. In particular, they analyse the current backlash against women's emancipation. Using new archival materials and the insights of feminist theory, the contributors explore the relevance of gender equality and difference in Russian history. They find that women have not merely submitted to the patriarchal system, but instead have found creative ways of resisting it. Chapters focusing on contemporary Russia discuss abortion, pornography, sexual minorities, young women's lifestyles, the impact of economic reform on women and the development of the women's movement. This book will be of interest to students and specialists in Russian, Ukrainian and women's studies, as well as to historians, political scientists, sociologists and economists.

She is the author of *Women in the Soviet Countryside* (Cambridge: Cambridge University Press, 1987) and numerous articles on women in Russia. Donald Filtzer is Senior Lecturer in European Studies at the University of East London. He recently completed the third volume of his historical study of industrial workers in the Soviet Union: *Soviet Workers and Stalinist Industrialization* (London: Pluto, 1986); *Soviet Workers and De-Stalinization* (Cambridge: Cambridge University Press, 1992); and *Soviet Workers and the Collapse of Perestroika* (Cambridge: Cambridge University Press, 1994). Part of his research has involved an analysis of the role of female labour in the political economy of the Soviet system.

She has contributed to the *Modern Encyclopedia of Russian and Soviet History*, and written more than thirty articles. She has an MA from the Institute of Soviet and East European Studies, Carleton University, Ottawa, where she was research assistant to Professor R. C. Melanie Ilic is Senior Lecturer and Field Chair for Women's Studies at Cheltenham and Gloucester College of Higher Education, where she also teaches Russian and Soviet History. She is an Honorary Research Fellow and Research Consultant at the Centre for Russian and East European Studies, University of Birmingham, where she is also currently registered for a Ph.D on the protection of female labour in the Soviet Union in the 1920s and 1930s.

Catriona Kelly is Lecturer in Russian Language and Literature at the School of Slavonic and East European Studies, University of London, and was formerly a British Academy Post-Doctoral Fellow at Christ Church, University of Oxford. She is the author of *A History of Russian Women's Writing, 1820–1992* and the editor of *An Anthology of Russian Women's Writing, 1777–1992* (both published by Oxford University Press in 1994); author of *Petrushka, the Russian Carnival Puppet Theatre* (Cambridge: Cambridge University Press, 1990); and author of numerous articles on Russian women's writing and on popular culture. Authors whom she has translated from Russian include Leonid Borodin, Sergei Kaledin, and the poets Elena Shvarts, Anna Barkova and Ol'ga Sedakova.

Rosalind Marsh is Professor of Russian Studies and Director of the Centre of Women's Studies at the University of Bath. She was awarded an MA at Cambridge and a DPhil. at Oxford. She taught at the Queen's University of Belfast from 1977 to 1987, and at the University of Exeter from 1987 to 1991, where she was Director of the Centre for Russian, Soviet and East European Studies from 1989 to 1991. She is the author of *Soviet Fiction since Stalin: Science, Politics and Literature* (London and Sydney: Croom Helm, 1986), *Images of Dictatorship: Stalin in Literature* (London and New York: Routledge, 1989) and *History and Literature in Contemporary Russia, 1985–1994* (Basingstoke: Macmillan, 1995). Her articles on Russian women and women's literature include 'The Birth, Death and Rebirth of Feminist Writing in Russia', in Helena Forsås-Scott (ed.), *Textual Liberation: European Feminist Writing in the Twentieth Century* (London: Routledge, 1991). She has just completed editing *Gender and Russian Literature: New Perspectives* for Cambridge University Press.

Shane O'Rourke is Lecturer in the Department of History, University of York. He has a BA and an MA from the University of East Anglia, and a DPhil. from the University of Oxford. His doctoral thesis was entitled 'Warriors and Peasants: The Contradictions of Cossack Culture, 1861–1914'.

Solomea Pavlychko is a research associate at the Institute of Literature of the Academy of Sciences of Ukraine in Kiev. She is the author, in Ukrainian, of *Byron; His Life and Work* (Kiev: Dnipro, 1989) and *Labyrinths of Thought: The Intellectual Novel of Great Britain* (Kiev: Naukova Dumka, 1993); in Russian, of *Transcendental Poetry of American Romanticism: Emerson, Whitman, Dickinson* (Kiev: Naukova Dumka, 1988); and in English, of *Letters from Kiev* (New York: St Martin's Press,

1992). She has translated into Ukrainian *Lord of the Flies* by William Golding and *Lady Chatterley's Lover* by D. H. Lawrence, and has written numerous articles on English and American literature and the women's movement in Ukraine. She was a founder member of the Women's Community of Rukh.

Hilary Pilkington is Lecturer in Russian Politics and Society at the Centre for Russian and East European Studies, University of Birmingham. She teaches post-Soviet politics and Russian culture and society, and her research interests are in the area of changing socio-cultural relations and identities. She is author of *Russia's Youth and Its Culture: A Nation's Constructors and Constructed* (London: Routledge, 1994) and co-editor of *Women in the Face of Change: The Soviet Union, Eastern Europe and China* (London: Routledge, 1992).

Anastasiia Posadskaia (Anastasia Posadskaya) has a Ph.D in economics from the Institute of Economics of the former USSR. She has undertaken sociological research into women's employment and other issues at the KamAZ plant and in the town of Taganrog. She was one of the four founder members of 'Lotos' – the League for Emancipation from Sexual Stereotypes – and since 1989 has been a director of the Moscow Centre for Gender Studies at the Institute for Research into Socio-Economic Problems of the Population of the Russian Academy of Sciences. She has written a number of articles on the contemporary situation of Russian women, and is the editor of *Women in Russia: A New Era in Russian Feminism* (London: Verso, 1994).

James Riordan is Professor of Russian Studies and Academic Head of the Department of Linguistic and International Studies at the University of Surrey. He studied at the Universities of Birmingham and London and Moscow State University, and has taught at the Universities of Portsmouth, Birmingham and Bradford. He is the author of numerous publications on sport, youth and sexuality in the former Soviet Union. His many books include *Soviet Youth Culture* (Basingstoke: Macmillan, 1989); *Sport, Politics and Communism* (Manchester: Manchester University Press, 1991); and *Soviet Social Reality in the Mirror of Glasnost* (New York: St Martin's Press, 1992). With Igor Kon he is editor of the ground-breaking *Sex and Russian Society* (London: Pluto Press, 1993).

Marian Rubchak is Associate Professor of European and Russian History at the University of Valparaiso, Indiana. She has an MA from Rutgers University, New Jersey and a Ph.D from the University of Illinois, Chicago. She edited, translated and introduced volume 5 of S. M. Solov'ev's *History of Russia from Earliest Times*, and is the author of various articles on Ukrainian history and politics, the Ukrainian émigré community, and contemporary feminism in Ukraine and Russia.

Elena Sargeant (née Kuz'mina) is Honorary Research Assistant in the History Department of the University of Aberdeen, where she has taught Russian language

and modern and contemporary European history since 1992. She was born in Ukraine in 1966; and in 1988 graduated with Honours from the History Department of Moscow State University, where she became a Candidate of Historical Sciences (Ph.D) in 1991. She has published several articles in the field of Slavic history, including a study of a previously unknown manuscript about the Russian satirist M. E. Saltykov-Shchedrin (1826–89) by the Bulgarian writer Zakhari Stoianov, which she discovered in a Bulgarian archive. Her research interests lie in the areas of Russian, Soviet and post-Soviet history, women's studies and modern and contemporary European history.

Susan Gross Solomon is Professor in the Department of Political Science at the University of Toronto. She was co-editor of *The Social Context of Soviet Science* with Linda Lubrano (Boulder, Colo.: Westview Press, 1980), co-editor with John F. Hutchinson of *Health and Society in Revolutionary Russia* (Bloomington: Indiana University Press, 1990), and editor of *Beyond Sovietology: Essays in Politics and History* (Armonk, N.Y.: M. E. Sharpe, 1994). She is now completing a monograph on Soviet social medicine in the inter-war years.

Elena Stishova is Professor at the Russian Institute of Cinematography, Moscow, and a critic, publicist and author of books and articles on contemporary Russian cinema. She edited the special feminist issue of the journal *Isskustvo kino*, no. 6 (1991).
