DANIEL H. BAYS is professor of history and director of the Asian studies programme at Calvin College, Grand Rapids, Michigan. He is professor emeritus at the University of Kansas. He is editor of *Christianity in China* (1996), and co-editor with Grant Wacker of *The Foreign Missionary Movement at Home* (2003).

RAOUL BIRNBAUM is professor of Buddhist studies at the University of California, Santa Cruz. His many publications focus on Buddhist practices and representations in China, from medieval times to the present.

NANCY N. CHEN is associate professor of anthropology at the University of California, Santa Cruz. A medical anthropologist, she is author of *Breathing Spaces: Qigong, Psychiatry, and Healing in China* (2003), and co-editor of *China Urban: Ethnographies of Contemporary Culture* (2001).

KENNETH DEAN is the Lee professor of Chinese culture in the department of East Asian studies, McGill University. He is the author of *First and Last Emperors: The Absolute State and the Body of the Despot* (with Brian Massumi), *Taoist Ritual and Popular Cults of Southeast China*, and *Lord of the Three in One: The Spread of a Cult in Southeast China*. He is currently editing several volumes of epigraphical materials on the history of religion in Fujian.

FAN LIZHU is professor of sociology at Fudan University, where she teaches sociology of religion, religion and Chinese society. Her most recent publication is *Religious Development in Contemporary China: A Case Study in Shenzhen*. Her current research focuses on temple festivals in northern China, and spiritual nourishment and religious development in China.

DRU C. GLADNEY is professor of Asian studies and anthropology at the University of Hawai'i at Manoa. He is author of *Muslim Chinese: Ethnic Nationalism in the People's Republic* (1996, second edition), *Ethnic Identity in China: The Making of a Muslim Minority Nationality* (1998), *Making Majorities: Constituting the Nation in Japan, China, Korea, Malaysia, Fiji, Turkey, and the U.S.* (editor, 1998), and *Dislocating China: Muslims, Minorities, and Other Sub-Altern Subjects* (in press). PAUL R. KATZ is an associate research fellow at the Institute of Modern History, Academia Sinica. He specializes in the study of local religious traditions in China and Taiwan. His most recent publications include *Demon Hordes and Burning Boats: The Cult of Marshal Wen in Late Imperial Chekiang* (1995), *The Cult of the Royal Lords in Taiwan* (in Chinese, 1997), and *Images of the Immortal. The Cult of Lü Dongbin at the Palace of Eternal Joy* (1999).

LAI CHI-TIM is associate professor of Daoism in the department of religion at the Chinese University of Hong Kong. He lectures on the history of Daoism, Daoist classics, Daoist ritual and Hong Kong Daoism. He received his PhD from the Divinity School, University of Chicago, in Daoism and the history of religion.

TIK-SANG LIU is assistant professor at the Hong Kong University of Science and Technology. His research interests focus on the coastal communities and local religious activities in the Zhu [Pearl] River estuary area of South China.
