Civic humanism has been one of the most influential of all concepts in the history of ideas. In this volume, an eminent team of political theorists and historians have been brought together to reassess the impact on the subject of the pioneering work of Hans Baron (1955) and J. G. A. Pocock (1975), creating a fresh intellectual landscape in which Renaissance civic humanism can be discussed.

Drawing from medieval to early modern traditions of political thought, this book evaluates civic humanism in the light of the emergence of oligarchy, imperialism, patronage politics, and the Medici ascendancy in Florence in the fourteenth to sixteenth centuries. It proposes new understandings of the evolution of important republican concepts such as liberty, the rule of law, virtue, and the common good. This thought-provoking collection represents a significant contribution to the study of republican political ideology in the Renaissance and modern periods.

JAMES HANKINS is Professor of History at Harvard University. His publications include *Plato in the Italian Renaissance*, 2 vols. (Brill, 1990), and numerous studies on Renaissance humanism and Platonism. He is the General Editor of the I Tatti Renaissance Library.
