The Enlightenment is an authoritative anthology of the key political writings from what Isaiah Berlin famously described as ‘the best and most hopeful episode in the history of mankind’. The texts themselves are supported by a lucid introduction exploring their moral, philosophical, political and economic background, enabling the student to grasp both the context and the essence of each argument. Biographical notes and carefully selected bibliographies offer further help. The selection includes not only mainstream theorists but also texts by authors actively engaged in the politics of the day, offering a broad and genuinely trans-European perspective. David Williams, a distinguished Enlightenment scholar, offers readers a view of the evolution of Enlightenment political thinking in a variety of contexts: natural law, the civil order, the nation state, government, civil rights, women’s rights, war and international relations, trade and economics, crime and punishment, and revolution. Students of political science, history, European studies, international relations, law and philosophy will find this an invaluable resource, and the most convenient and accessible single introduction to Enlightenment thinking currently available.

DAVID WILLIAMS is Professor of French at the University of Sheffield. He is the author of numerous books and articles on eighteenth-century French literature and thought, including the edition of *Voltaire: Political Writings* in Cambridge Texts in the History of Political Thought.
