PREFACE

This preposterous volume is the first instalment of a commentary on Velleius Paterculus which I hope in due course to complete. Although Velleius is the only historian of Roman affairs to have survived from the period which separates Livy and Tacitus, no commentary of comparable scale or scope has been published since the beginning of the nineteenth century.

The neglect of Velleius by commentators has extended to scholars in most other branches of classical learning and is due almost entirely to his treatment of the man who occupies what is marginally the largest single portion of his work – Tiberius. A historian who describes Tiberius in such enthusiastic terms, it is argued, cannot be trusted on any other matter and his work may be safely dismissed. The Tiberian narrative, which forms the last thirty-eight chapters of Velleius' work and covers the years 23 B.C.–A.D. 29, is thus of primary importance for any consideration of his history as a whole. It is for this reason that I am publishing the present volume here and now.

Although it is principally Velleius' value as a historian that has been called into question, the emphasis of this book is upon textual and literary, rather than historical, matters. Since we cannot assess an author's historical value unless we first know as accurately as possible what he wrote, and since Velleius' text is not only notoriously corrupt but has also suffered at the hands of most nineteenth- and twentieth-century editors through their misplaced confidence in MS A, the need for a detailed reappraisal of the text will, I hope, be understood. There has after all been no such thorough treatment since Kritz's outstanding commentary of 1840, which, apart from certain introductory sections, is concerned with textual criticism to the exclusion of all else. Whether the literary emphasis of this book will be equally welcome, I am not sure. But if one believes that in the ancient world the writing of history was primarily a literary activity and that historians were concerned rather with the

structured and dramatic presentation of their narrative than with the more ‘scientific’ aspects of their craft, there is every reason why works of ancient history should require a literary treatment. Indeed it is the persistent refusal of scholars to see Velleius’ Tiberian narrative in terms of the literary tradition that has largely contributed to the general disparagement of his history. Naturally my discussions of textual and literary matters have regularly led me into areas which more properly belong to experts in early imperial history; but I have often been able to limit my historical incursions by referring to such works as the latest comprehensive treatment of Tiberius available to me, the exemplary biography by Robin Seager, where a fuller account and bibliography may invariably be found. I nevertheless hope that by providing an improved text and by explaining the nature and meaning of the narrative I shall have done some service to those who wish to use Velleius as a historical source.

I have not thought it useful to provide either an account of Velleius’ family background and career or an outline of modern Velleian scholarship, tasks which have recently and admirably been taken up by G. V. Sumner and J. Hellegouarc’h respectively. Nor have I said anything in this volume about the dates of Velleius’ composition or the genre of historiography to which he belongs, since these are subjects which I have already discussed elsewhere.

I have several acknowledgements to make. Mr and Mrs E. H. Prater, through the kind offices of Dr B. R. Rees, passed to me the notes on Velleius which had been collected by their late son, John Prater, formerly Temporary Lecturer in Classics at Cardiff and Sheffield, and Assistant Classics Master at Bristol Grammar School at the time of his death. His bibliographical material was particularly helpful, on one notable occasion disclosing a brilliant emendation of 99.2 by Withof which had escaped successive editors of Velleius and which otherwise would certainly have escaped me. I am extremely grateful to Mr and Mrs Prater for their thoughtfulness and generosity.

PREFACE

Dr A. H. McDonald started me off on my research in Cambridge more than ten years ago: although he has not seen this book, I would like to believe that it contains evidence of his wise teaching. Miss Dorothy Monk kindly read the whole of the book in typescript and made a number of corrections and observations for which I am most grateful. In grappling with many of the historical, literary and textual problems which arose during the book's preparation I was greatly helped by Mr J. J. Patterson and Professor D. A. West, whose kindness, patience and scholarship I have shamelessly exploited.

Professor G. B. A. Fletcher, who first suggested Velleius to me as a topic for research, has read the whole of this book in typescript and generously furnished me with numerous valuable lexical notes which I have acknowledged throughout by the letter 'F.'. In addition he placed at my disposal his personal copies of the *editio princeps* and Kritz's now unobtainable commentary, the latter of which I have had on loan for five years. Professor F. R. D. Goodyear, who supervised my work for a year in Cambridge, has also read this book in typescript and given me the benefit of his penetrating criticism and expert knowledge of early imperial historiography. In addition he was of particular assistance when the book was approaching readiness for publication. To these two friends above all I am indebted for their many suggestions and corrections: without the aid of their scholarship and erudition the book would have been greatly impoverished.

The book would not have been published at all if my University had not provided financial assistance of an order which would have been most generous under ordinary economic circumstances but which in the present crisis places me all the more in its debt. Finally I owe my thanks to Mr I. M. Le M. DuQuesnay for nobly agreeing to read the proofs, and to the staff of the Cambridge University Press for their kind and expert attention.

Note on emendations. Almost every emendation recorded in this volume may be traced to its original source by using the works listed under B and C above.
