The book covers all aspects of the field, including descriptions of different types of delinquency and time trends, the state of knowledge on the individual, social–psychological and cultural factors involved, and recent advances in prevention and intervention. The authors bring together a wide range of disciplinary perspectives in order to provide a comprehensive account of antisocial behavior in youth.

Sir Michael Rutter is Professor of Child Psychiatry at the University of London's Institute of Psychiatry. An international authority on child development and child psychiatry, Rutter's research has earned him numerous awards and honors, including the American Psychological Association Distinguished Scientific Contribution Award, the Castilla del Pino Prize for Achievement in Psychiatry, and the Helmut Horten award for research on autism. His previous books with Cambridge University Press include Psychosocial Disturbances in Young People as well as Biological Risk Factors for Psychosocial Disorders and Stress, Risk, and Resilience in Children and Adolescents.

Henri Giller is Managing Director of Social Information Systems, Ltd. After receiving his Ph.D. from the Institute of Criminology at the University of Cambridge, Giller has served as a Fellow at the University of London's Institute of Psychiatry and a Lecturer in Law at the University of Keele. His previous books include Juvenile Delinquency Trends and Perspectives (Penguin) and Understanding Juvenile Justice (Croom Helm). Giller is a founding member of the International Workshop on Juvenile Criminology.

Ann Hagell is Co-Director of the new Policy Research Bureau in London, where she specializes in policy research on young offenders, antisocial behavior problems, at-risk young people, and parenting problems. Previously she has been a Senior Fellow at the Policy Studies Institute, a Fulbright scholar at the University of North Carolina, and a Research Scientist in Professor Rutter's research team at the MRC Child Psychiatry Unit, where she also completed her Ph.D.
