## REPRESENTATIONS OF THE SELF FROM THE RENAISSANCE TO ROMANTICISM

In this volume a team of international contributors explore the way modern conceptions of what constitutes an individual's life-story emerged in the seventeenth and eighteenth centuries. The Enlightenment idea of the self – an autonomous individual, testing rules imposed from without against a personal sensibility nourished from within – is today vigorously contested. By analyzing early-modern “life writing” in all its variety, from private diaries and correspondences to public confessions and philosophical portraits, this volume shows that the relation between self and community is more complex and more intimate than supposed. Spanning the period from the end of the Renaissance to the eve of Romanticism in Western Europe, a period in which the explosion of print culture afforded unprecedented opportunities for the circulation of life-stories from all classes, this book examines the public assertion of self by men and women in England, France, and Germany from the Renaissance to Romanticism.

Patrick Coleman is Professor of French at the University of California, Los Angeles. His books include *Rousseau's Political Imagination: Rule and Representation in the “Lettre à d'Alembert”* (1984) and *The Limits of Sympathy: Gabrielle Roy's “The Tin Flute”* (1993). He edited Rousseau's *Discourse on Inequality* (1994) and co-edited *The Swiss Enlightenment: Reconceptualizing Nature, Science, and Aesthetics* (1998).

Jayne Lewis is Associate Professor of French at the University of California, Los Angeles. She is author of *The English Fable: Aesop and Literary Culture 1651–1740* (1996), *Mary Queen of Scots: Romance and Nation* (1998) and *The Trial of Mary Queen of Scots: Sixteenth Century Crises of Female Rule* (1998).

Jill Kowalik is Associate Professor of Germanic Languages at the University of California, Los Angeles. She is author of *The Poetics of Historical Perspectivism: Breitinger's Critische Dichtkunst and the Neoclassic Tradition* (1992).
