The Cambridge Companion to Ancient Greek Political Thought offers a guide to understanding the central texts and problems in ancient Greek political thought, from Homer through the Stoics and Epicureans. Composed of essays specially commissioned for this volume and written by leading scholars of classics, political science, and philosophy, the *Companion* brings these texts to life by analyzing what they have to tell us about the problems of political life. Focusing on texts by Homer, Herodotus, Thucydides, Plato, and Aristotle, among others, it examines perennial issues, including rights and virtues, democracy and the rule of law, community formation and maintenance, and the ways in which theorizing of several genres can and cannot assist political practice.

Stephen Salkever is Katharine Woodworth Professor of Political Science at Bryn Mawr College. He is the author of *Finding the Mean: Theory and Practice in Aristotelian Political Philosophy* (1990), as well as numerous articles and chapters on ancient and modern political philosophy. His research has been supported by fellowships from the National Endowment for the Humanities and the National Humanities Center, and he has received teaching awards from Bryn Mawr and from the Council for Advancement and Support of Education.

RYAN K. BALOT is Associate Professor of Political Science at the University of Toronto. The author of *Greed and Injustice in Classical Athens* (Princeton University Press, 2001) and of *Greek Political Thought* (Blackwell, 2006), he specializes in the history of political thought. He received his doctorate in classics at Princeton University and his B.A. degrees in classics from University of North Carolina at Chapel Hill and Corpus Christi College, Oxford, where he studied as a Rhodes Scholar. SUSAN BICKFORD is Associate Professor of Political Science at the University of North Carolina at Chapel Hill. She is the author of *The Dissonance of Democracy: Listening, Conflict, and Citizenship* (Cornell University Press, 1996) as well as articles on feminist political theory, democratic theory, and ancient Greek political thought.

ERIC BROWN is Associate Professor of Philosophy at Washington University in St. Louis and is the author of several articles on Greek and Roman philosophy and of *Stoic Cosmopolitanism* (Cambridge University Press, forthcoming). FRED D. MILLER, JR., is Professor of Philosophy and Executive Director of the Social Philosophy and Policy Center at Bowling Green State University. He is the author of *Nature, Justice, and Rights in Aristotle's Politics* (Oxford University Press, 1995) and co-editor of *Freedom, Reason, and the Polis: Essays in Ancient Greek Political Philosophy* (Cambridge University Press, 2007) and *A History of the Philosophy of Law from the Ancient Greeks to the Scholastics* (Springer, 2007). He served as president of the Society for Ancient Greek Philosophy from 1988 to 2004.

NORMA THOMPSON is Associate Director of the Whitney Humanities Center and Senior Lecturer in the Humanities at Yale University. She received her A.B. from Bowdoin College and her Ph.D. from The Committee on Social Thought at the University of Chicago. Her scholarship and teaching are in the humanities, with special interests in political philosophy and politics and literature. She is the Director of Undergraduate Studies for the humanities major at Yale College. Her latest book is *Unreasonable Doubt: Circumstantial Evidence and an Ordinary Murder in New Haven* (University of Missouri Press, 2006). She has published two books with Yale University Press: *Herodotus and the Origins of the Political Community: Arion's Leap* (1996) and *The Ship of State: Politics and Statecraft from Ancient Greece to Democratic America* (2001). She edited the volume *Instilling Ethics* with Rowman & Littlefield (2000) and has also published articles in *Arion*, *Nomos*, and *International Journal of the Classical Tradition*, and in the festschrift for David Grene, *Literary Imagination, Ancient and Modern*.
