The *Cambridge History of Religions in Latin America* covers religious history in Latin America from pre-Conquest times until the present. This publication is significant because of the historical and contemporary centrality of religion in the life of Latin America, a region that has been growing in global importance. It is also timely because of the rapid process of religious change that the region is undergoing. And lastly, it is significant because of the region's religious distinctiveness in global comparative terms, which contributes to its importance for debates over religion, globalization, and modernity. This volume incorporates new currents in scholarship to address the breadth of Latin American religion, including religions of the African diaspora, indigenous spiritual expressions, new religious movements, alternative spiritualities, and secularizing tendencies.

VIRGINIA GARRARD-BURNETT is a professor of history at the University of Texas, Austin. She has authored numerous articles and chapters; edited three collected volumes (of which this is the fourth); and written two monographs, the most recent of which is entitled *Terror in the Land of the Holy Spirit: Guatemala Under General Efraín Ríos Montt, 1982–1983* (2010). Her forthcoming monograph is on new Christian movements in Latin America, and she is currently co-authoring the *Oxford History of Modern Latin America*.

PAUL FRESTON is the CIGI Chair in Religion and Politics in Global Context at the Balsillie School of International Affairs and Wilfrid Laurier University, Canada. He is also professor colaborador on the post-graduate programme in sociology at the Universidade Federal de São Carlos, Brazil. He has worked mainly on religion and politics, the growth of popular forms of Protestantism in Latin America, and questions of religion and globalization. His books include *Evangelicals and Politics in Asia, Africa and Latin America* (Cambridge University Press, 2001); *Protestant Political Parties: a Global Survey* (2004); (ed.) *Evangelical Christianity and Democracy in Latin America* (2008); and (coauthored) *Nem Anjos Nem Demônios: Interpretações Sociológicas do Pentecostalismo* (1994).

STEPHEN C. DOVE is an assistant professor of history and Latin American studies at Centre College. He earned his PhD at the University of Texas, Austin and has published several articles about Protestantism and Pentecostalism in Latin America. His current book manuscript is a study of the transition from missionary to local Protestantism in early-twentieth-century Guatemala.

He has conducted ethnographic research mostly in Brazil but also in Barbados and New Bedford, Massachusetts on a wide range of problems, including family and kinship, patronage and politics, entrepreneurship, Spiritist surgery and healing, syncretized religions and Evangelical Protestants in Brazilian politics. He has conducted ethnohistorical and historical research in Portugal and the Atlantic Islands on the history of slavery and plantations. He is the author or editor of eight books; producer, director, and author of five video documentaries; and has published some 140 articles and reviews in books and professional journals. At present he is completing a book in Portuguese with a Brazilian colleague on Evangelicals in Brazilian politics.

RAMÓN A. GUTIÉRREZ is the Preston & Sterling Morton Distinguished Service Professor of United States History and the College at the University of Chicago. He is the author of *When Jesus Came the Corn Mothers Went Away: Marriage, Sexuality, and Power in New Mexico, 1500–1846* (Stanford University Press, 1991) and the co-editor of *Mexicans in California: Transformations and Challenges* (University of Illinois Press, 2009).

He is a socio-cultural anthropologist with research specializations in Bolivia, where he has conducted ethnographic research with Aymara communities since 1989.
