An Economic and Social History of the Netherlands, 1800–1920 provides a comprehensive account of Dutch history from the late eighteenth to the early twentieth century, examining population and health, the economy, and socio-political history. The Dutch experience in this period is fascinating and instructive: the country saw extremely rapid population growth, awesome death rates, staggering fertility, some of the fastest economic growth in the world, a uniquely large and efficient service sector, a vast and profitable overseas empire, characteristic 'pillarization', and relative tolerance. Michael Wintle also examines the lives of ordinary people: what they ate, how much they earned, what they thought about public affairs, and how they wooed and wed. This is the only single-authored book currently available in English on this crucial period of Dutch history, and it will be of central importance to Dutch specialists, as well as to European historians more generally.

MICHAEL WINTLE is Professor and head of the Department of European Studies at the University of Hull. He has also taught at Utrecht, Victoria (Canada) and Amsterdam. His research interests are in the modern social and economic history of the Low Countries, European identity (especially the visual representation of Europe) and European industrialization. He has published widely on the history of the Netherlands. Recent books include *The Idea of a United Europe* (2000) and *Culture and Identity in Europe* (1996).
