Matters of Culture

American sociology is in the midst of a cultural turn. Where sociologists once spurned culture, today they embrace and explore it, seeking to understand the construction of social forms and the way culture matters. Problems of meaning, discourse, aesthetics, value, textuality, form, and narrativity, topics traditionally within the humanists' purview, have come to the fore as sociologists increasingly emphasize the role of meanings, symbols, cultural frames, and cognitive schema in their theorizations of social process and institution. *Matters of Culture* is an introduction to some of the best theorizing in cultural sociology, focusing in particular on questions of power, the sacred, and cultural production. With a major theoretical introduction that lays out the internal structure of the field and its relation to cultural studies and contributions from leading academics, *Matters of Culture* offers students and professors alike a representative range of the types of cultural sociological analysis available.

Jeffrey Alexander, Professor of Sociology at Yale University, works in the areas of theory, culture, and politics. An exponent of the “strong program” in cultural sociology, he has investigated the cultural codes and narratives that inform such diverse areas as computer technology, environmental politics, war-making, the Watergate crisis, and civil society. In the field of politics, Alexander is finishing a theory of the civil sphere and its contradictions. Alexander’s work moves between the history of social thought, interpretive disputes, and the construction of systematic models. His most recent publication is *The Meanings of Social Life: A Cultural Sociology* (Oxford, 2003).

Denise D. Bielby is Professor of Sociology and Affiliated Faculty, Center for Film, Television, and New Media at the University of California, Santa Barbara. Her research focuses on sociology of culture, mass media, and gender. She is the author of numerous scholarly articles which have appeared in *American Sociological Review*, *American Journal of Sociology*, *Poetics*, *Journal of Popular Culture*, *Journal of Broadcasting and Electronic Media*, and *Television and New Media*.

William Bielby’s research interests are in the areas of organizations and inequality, with a focus on workplace discrimination by gender, race, and age. Much of his work over the past decade, in collaboration with Denise Bielby, has applied those interests to the study of cultural production and labor market stratification in the entertainment industry. Currently, he is completing a study of the first wave of teenage rock and roll bands in the post-Elvis, pre-Beatles era.

Jon Cruz is Associate Professor of Sociology at the University of California, Santa Barbara. His is author of *Culture on the Margins: The Black Spiritual and the Rise of American Cultural Interpretation* (Princeton, 1999), and *Viewing, Reading, Listening: Audiences and Cultural Reception* (co-editor)

A Political-Philosophical Exchange* (2003), with Axel Honneth; *Justice Interruptus: Critical Reflections on the "Postsocialist" Condition* (1997); *Feminist Contentions: A Philosophical Exchange* (1994) with Seyla Benhabib, Judith Butler, and Drucilla Cornell; and *Unruly Practices: Power, Discourse, and Gender in Contemporary Social Theory* (1989). She is a co-editor of *Pragmatism, Critique, Judgment: Essays for Richard J. Bernstein* (2003) and *Revaluing French Feminism: Critical Essays on Difference, Agency, and Culture* (1992). Her current research is on globalization.

Roger Friedland is Professor of Religious Studies and Sociology at the University of California, Santa Barbara. Together with John Mohr, he co-founded The Cultural Turn. Friedland, who is doing comparative research on religious nationalism, is author of "Money, Sex and God: The Erotic Logic of Religious Nationalism," *Sociological Theory*, 2002. He is currently finishing a study of Frank Lloyd Wright's Taliesin Fellowship with Harold Zellman, a Los Angeles-based architect.

John R. Hall is a Professor of Sociology and Director of the Center for History, Society, and Culture at the University of California – Davis. His most recent books are an edited volume – *Reworking Class* (Cornell University Press, 1997), *Cultures of Inquiry: From Epistemology to Discourse in the Methodological Practices of Sociohistorical Research* (Cambridge University Press, 1999), *Apocalypse Observed: Religious Movements and Violence in North America, Europe, and Japan*, coauthored by Philip D. Schuyler and Sylvaine Trinh (Routledge, 2000), and *Sociology on Culture*, co-authored by Mary Jo Neitz and Marshall Battani (Routledge, 2003). His current research concerns apocalyptic terrorism and modernity.

of California Press, 2000). Friedland and Hecht have written extensively on the politics and religion of sacred places. Hecht is the Associate Editor with Ninian Smart for the series *Religions of the World* (Laurence King in London and Prentice-Hall in New York) and is completing a book on religion and contemporary art.

Magali Sarfatti Larson is the author of, among other things, *The Rise of Professionalism* and *Beyond the Postmodern Façade: Architectural Change in Late Twentieth Century America*, which received awards from the American Institute of Architects and the Sociology of Culture section of the American Sociological Association. She has held the chair of Sociology of Labor at the University of Urbino in Italy from 1997 to 2001 and is Professor Emerita from Temple University. She lives in Philadelphia and her current interests are political culture and politics *tout court*.

John Mohr is Associate Professor of Sociology at the University of California, Santa Barbara where he also serves as Associate Dean of the Graduate Division. He has been a visiting professor at La Sapienza in Rome and at the Maison des Sciences de L'Homme, in Paris. He has published articles on the measurement of meaning structures, on the history of the American welfare state and (with Paul DiMaggio) on the measurement of cultural capital. He is currently studying organizational responses to the end of affirmative action in California higher education. He is the editor of a special issue of *Poetics* on the topic of "Relational Analysis and Institutional Meanings: Formal Models for the Study of Culture" (2000) and co-founder, with Roger Friedland, of the Cultural Turn conference series at the University of California, Santa Barbara.

Harvey Molotch's most recent book, *Where Stuff Comes From*, uses product design as a way to understand the link between culture and economy. Formerly on the faculty at the University of California, Santa Barbara (and Centennial Professor at the London School of Economics) he is now Professor of Sociology and Metropolitan Studies at New York University.

Orlando Patterson is John Cowles Professor of Sociology at Harvard University. He is the author of *The Sociology of Slavery* (1967), *Ethnic Chauvinism* (1977), *Slavery and Social Death* (1982), *Freedom in the Making of Western Culture* (1991), *The Ordeal of Integration* (1997), and *Rituals of Blood* (1999), as well as three novels. Patterson was awarded the Distinguished Contribution to Scholarship Award of the American Sociological Association in 1983 (The Sorokin Prize), and was co-winner of the Ralph Bunche Award of the American Political Science Association for the best scholarly work on the subject of pluralism. In 1991 he was awarded the National Book Award in non-fiction for

Steven Seidman is author most recently of *Beyond the Closet: The Transformation of Gay and Lesbian Life* (2002) and teaches sociology at the University at Albany.

Mark A. Schneider is Associate Professor of Sociology at Southern Illinois University-Carbondale. One of his central interests, pursued in *Culture and Enchantment* (University of Chicago Press, 1993), is the relationship between humanistic and scientific approaches to culture. He has published on a range of topics, including the structuralist character of Goethe's scientific writings, the social origins of the sacred, and olfactory mechanisms in incest avoidance.
