## African Politics in Comparative Perspective

This book reviews fifty years of research on politics in Africa. It synthesizes insights from different scholarly approaches and offers an original interpretation of the knowledge accumulated over the years. It discusses how research on African politics relates to the study of politics in other regions and mainstream theories in comparative politics. It focuses on such key issues as the legacy of a movement approach to political change, the nature of the state, the economy of affection, the policy deficit, the agrarian question, gender and politics, and ethnicity and conflict. It concludes by reviewing what scholars agree upon and what the accumulated knowledge offers as insights for more effective political and policy reforms. This book is an ideal text in undergraduate and graduate courses in African and comparative politics as well as in development-oriented courses in political science and related disciplines. It is also of great relevance to governance and development analysts and to practitioners in international organizations.

Goran Hyden is distinguished professor in political science at the University of Florida. His publications include *Beyond Ujamaa in Tanzania* (1980); *No Shortcuts to Progress* (1983); *Governance and Politics in Africa*, coedited with Michael Bratton (1992); and *Making Sense of Governance*, coauthored with Julius Court and Kenneth Mease (2004). He served as president of the African Studies Association in 1995. He has also served as a consultant on African development to many international agencies.

## Acknowledgments

This book has been long in the making. Due to many other commitments, not the least being to finish a number of joint projects with other scholars, the opportunity to complete this manuscript was constantly pushed backward. I am glad that during the spring of 2004 I was able to finish a first draft and, subsequently during the second part of the year, revise it in the light of comments received from colleagues and reviewers.

This project is a celebration of fifty years of political science research on Africa. It is also a humble attempt on my part to summarize it and draw my own conclusions from the knowledge that has been accumulated over the past five decades. Many colleagues over the years have been very helpful in shaping my own thinking about Africa, whether or not they have agreed with the conclusions I have drawn. It is appropriate that I first mention my three most important intellectual mentors – individuals who have inspired my curiosity and also helped me develop as a professional. The late James S. Coleman, perhaps the foremost Africanist of the early generation of scholars, gave me intellectual encouragement and leadership at a time in my young career when I was still looking for direction. So did Colin Leys, whom I had the benefit of interacting with at Makerere and Nairobi Universities in the late 1960s and early 1970s. I also count Robert W. Kates among those who have helped form my thinking about Africa and the world. Bob and I were both at the University of Dar es Salaam, but our intellectual encounters came especially in the late 1980s and early 1990s when Bob was director of the Alan Shawn Feinstein World Hunger Program at Brown University in Providence, Rhode Island, and I had the fortune of serving – on a part-time basis – as his associate director.

Over the years I have also benefited greatly from comments and advice from many political science colleagues. I cannot list them all, but I would like to mention especially Professor Emeritus Crawford Young at University of Wisconsin; Professor David Leonard, University of California, Berkeley; Professor Joel Barkan, University of Iowa; Professor Nelson Kasfir of
