Known as the 'Father of modern theology' Friedrich Schleiermacher is without a doubt one of the most important theologians in the history of Christianity. Not only relevant to theology, he also made significant contributions in areas of philosophy such as hermeneutics, ethics, philosophy of religion, and the study of Plato, and he was ahead of his time in espousing a kind of proto-feminism. Divided into three parts, this Companion deals first with elements of Schleiermacher's philosophy, such as metaphysics, epistemology of religious knowledge, ethics, hermeneutics, and contributions to Plato scholarship. Second it discusses theological topics such as sin and redemption and Christology, and the final section is devoted to Schleiermacher's understanding of culture. This is the first book in English introducing readers to all the important aspects of Schleiermacher's thought in a systematic way, containing essays by the some of the best Schleiermacher scholars in Germany and in the English-speaking world.

JACQUELINE MARINA is Associate Professor of Philosophy at Purdue University. She specializes in Kant, Schleiermacher, and philosophy of religion. She has published a number of book chapters and scholarly articles that have appeared in the following journals: *Journal of the History of Philosophy*, *Kant-Studien*, *Faith and Philosophy*, *Journal of Religion*, and *Religious Studies*. She is currently at work on a book entitled *Transformation of the Self in the Thought of Friedrich Schleiermacher*.

Notes on contributors

Robert Merrihew Adams taught philosophy for many years at UCLA, and retired recently from the Clark Professorship of Moral Philosophy and Metaphysics at Yale University. He is currently a Visiting Professor of Philosophy at the University of Oxford, where he is also a Senior Research Fellow of Mansfield College. His publications include *The Virtue of Faith and Other Essays in Philosophical Theology* (1987), *Leibniz: Determinist, Theist, Idealist* (1994), and *Finite and Infinite Goods: A Framework for Ethics* (1999).

Frederick C. Beiser is Professor of Philosophy at Syracuse University. He has been a major contributor to work on the history of modern philosophy, especially the history of German philosophy (Kant and German idealism) and the English Enlightenment. His book *The Fate of Reason: German Philosophy from Kant to Fichte* won the 1987 Thomas J. Wilson Prize for the best first book. He is the editor of *The Cambridge Companion to Hegel*. He has won Thyssen and Humboldt research fellowships to study at the Free University of Berlin and was a 1994 Guggenheim Fellow. He received a 1999–2000 NEH Faculty Fellowship (at Indiana University), and he has won awards for his outstanding undergraduate teaching.

Andrew Bowie is Professor of Philosophy and German at Royal Holloway College, University of London. His books include: *Schelling and Modern European Philosophy* (1993), *From Romanticism to Critical Theory* (1997), *Aesthetics and Subjectivity: From Kant to Nietzsche* (2003), and *Introduction to German Philosophy from Kant to Habermas* (2003), and he has translated editions of Schelling's *On the History of Modern Philosophy* and Schleiermacher's *Hermeneutics and Criticism*. He is currently writing a book, *Music, Philosophy, and Modernity*.
