Acknowledgements

This work is the outcome of many interesting years of research on the geography of Scotland spent on both sides of the border. It would be wrong to deny that the unique aspects of the humanised landscape have always been a major source of inspiration and that this modest contribution arises from a conviction that the sparsity of publications on Scotland's historical geography stands in inverse relation to the intrinsic interest of this topic. Nevertheless it is possible to show that the Scottish experience with modernisation exemplifies many of the general principles that have been advanced in different branches of social science.
