

LATE HELLENISTIC GREEK LITERATURE IN DIALOGUE

Late Hellenistic Greek literature, both prose and poetry, stands out for its richness and diversity. Recent work has tended to take an author-by-author approach that underestimates the interconnectedness of the literary culture of the period. The chapters assembled here set out to change that by offering new readings of a wide range of late Hellenistic texts and genres, including historiography, geography, rhetoric and philosophy, together with many verse texts and inscriptions. In the process, they offer new insights into the various ways in which late Hellenistic literature engaged with its social, cultural and political contexts, while interrogating and revising some of the standard narratives of the relationship between late Hellenistic and imperial Greek literary culture, which are too often studied in isolation from each other. As a whole the book prompts us to rethink the place of late Hellenistic literature within the wider landscape of Greek and Roman literary history.

JASON KÖNIG is Professor of Classics at the University of St Andrews. He has published widely on the Greek literature and culture of the Roman Empire. His books include Athletics and Literature in the Roman Empire (Cambridge, 2005) and Saints and Symposiasts: The Literature of Food and the Symposium in Greco-Roman and Early Christian Culture (Cambridge, 2012).

NICOLAS WIATER is Senior Lecturer in Classics at the University of St Andrews. He specialises in Hellenistic and early imperial Greek literature. His publications include *The Ideology of Classicism: Language, History, and Identity in Dionysius of Halicarnassus* (Berlin, 2011) and, with T. A. Schmitz, *The Struggle for Identity. Greeks and their Past in the First Century* BCE (Stuttgart, 2011).

MARIO BAUMANN is Juniorprofessor für Kulturen der Antike/Griechische Literatur at Technische Universität Dresden. He is the author of *Bilder schreiben: Virtuose Ekphrasis in Philostrats Eikones* (De Gruyter, 2011) and *Welt erzählen: Narration und das Vergnügen des Lesers in der ersten Pentade von Diodors Bibliotheke* (Vandenhoeck & Ruprecht, 2020). His current major research project, funded by the Deutsche Forschungsgemeinschaft (DFG), is a commentary on Herodian's *History of the Empire from the Death of Marcus*.

JOY CONNOLLY is President of the American Council of Learned Societies, after service as provost and interim president of the CUNY Graduate Center and as dean for humanities at NYU. She is the author of two books, including *The Life of Roman Republicanism* (Princeton University Press, 2014), and over seventy scholarly articles and essays and reviews in the popular press. She is currently preparing a series of lectures on classical studies in the contemporary world for the University of Pennsylvania, which will be published by Princeton University Press.

CASPER C. DE JONGE is Professor of Greek Language and Literature at Leiden University. His research concentrates on Greek literature in the Roman world, ancient migrant literature, ancient literary criticism, classical rhetoric, the sublime, and the reception of antiquity in classical music. He has received Veni and Vidi grants from the Netherlands Organization of Scientific Research (NWO).

SIMON GOLDHILL is Professor of Greek at the University of Cambridge, and Foreign Secretary of the British Academy. He has written broadly on Greek literature and culture: his works have been translated into ten languages and won three international prizes. He has lectured all over the world and has broadcast regularly on radio and television in the UK, USA, Canada, and Australia. His most recent book is *Preposterous*

BENJAMIN GRAY is Senior Lecturer in Ancient History at Birkbeck, University of London. He is the author of *Stasis and Stability: Exile, the Polis, and Political Thought, c. 404–146 BC* (Oxford University Press, 2015) and co-editor of *The Hellenistic Reception of Classical Athenian Democracy and Political Thought* (Oxford University Press, 2018, with M. Canevaro). He is currently working on a project, from which his chapter in this volume derives, on the interaction between political thought and civic rhetoric in the later Hellenistic world.

EMMA GREENSMITH is Associate Professor of Classical Languages and Literature at the University of Oxford and a Fellow of St John's College. She specialises in imperial Greek literature, particularly epic, poetics and religious culture. Her recent book, *The Resurrection of Homer in Imperial Greek Epic: Quintus Smyrnaeus' Posthomerica and the Poetics of Impersonation* (Cambridge University Press, 2020), offers a new reading of the role of epic and the reception of Homer in Greco-Roman poetic culture. She has also written recent articles on Nonnus, Triphiodorus and Colluthus, and is editing a new *Cambridge Companion to Greek Epic*.

MYRTO HATZIMICHALI is University Senior Lecturer in Classics (Philosophy) at the University of Cambridge. She is author of *Potamo of Alexandria and the Emergence of Eclecticism in Late Hellenistic Philosophy* (Cambridge University Press, 2011). Her research interests include Greco-Roman philosophy in the first century BCE (where she has published on the fate of the Aristotelian corpus, the doxography of Arius Didymus, Antiochus of Ascalon and Philodemus). They also range over Greek intellectual life more broadly, with publications on the Library of Alexandria and the scholars associated with it, including the Jewish author of the *Letter of Aristeas*. She is currently working on a series of papers on Aristotle's biological works.

LAWRENCE KIM is Professor of Classical Studies at Trinity University in San Antonio, Texas. He is the author of *Homer between History and Fiction in Imperial Greek Literature* (Cambridge University Press, 2010) as well as numerous articles on the ancient novel, ancient literary criticism, Atticism and imperial Greek prose literature. His current project treats the idea of the 'archaic' in Greek and Latin literary-historical thinking.

JASON KÖNIG is Professor of Greek at the University of St Andrews. He has published widely on the Greek literature and culture of the Roman Empire. His publications include Athletics and Literature in the Roman Empire (Cambridge University Press, 2005), Saints and Symposiasts: The Literature of Food and the Symposium in Greco-Roman and Early Christian Culture (Cambridge University Press, 2012), and a series of volumes on knowledge-ordering and encyclopaedic writing in the imperial period. He is currently working on representations of landscape, environment, and especially mountains in ancient Mediterranean culture. His latest book, The Folds of Olympus: Mountains in Ancient Greek and Roman Culture, is forthcoming with Princeton University Press.

FELIX K. MAIER is Heisenberg Professor at the University of Würzburg (Germany). His research centres on ancient Greek historiography, imperial representation in Late Antiquity, conflict escalation models and Digital Classics. He is the author of the monographs Überall mit dem Unerwarteten rechnen: Die Kontingenz historischer Prozesse bei Polybios (C. H. Beck, 2012) and Palastrevolution: Der Weg zum hauptstädtischen Kaisertum im Römischen Reich des vierten Jahrhunderts (Brill, 2019). He is also the chief editor of Die Fragmente der Griechischen Historiker Part v. Currently he is working on identity and power in the early imperial era.

THOMAS A. SCHMITZ studied classics and comparative literature in Bonn, Paris and Harvard. He teaches Greek Literature at Bonn University and has held positions at Kiel, Heidelberg, Frankfurt, Stanford and Paris. His main research interests are imperial Greek culture, the connections between modern literary theories and classical texts, and classical receptions. He has published on imperial Greek literature, Hellenistic poetry, and literary theory. His most recent book is a commented edition of Sophocles' *Electra* (De Gruyter, 2016). He is currently preparing a book on the classical tradition in European literature.

NICOLAS WIATER is Senior Lecturer in Classics at the University of St Andrews. He specialises in Hellenistic and early imperial Greek literature, especially Greek authors engaging with Rome. His major publications include *The Ideology of Classicism: Language, History, and Identity in Dionysius of Halicarnassus* (De Gruyter, 2011), a multivolume German translation, with introduction and commentary, of Dionysius' *Early Roman History* (so far, 2 vols, Hiersemann, 2014,

2018), and *The Struggle for Identity: Greeks and Their Past in the First Century BCE*, co-edited with Thomas A. Schmitz (Franz Steiner Verlag, 2011).
