He has published peer-reviewed articles in *International Studies Perspectives*, *Korea Observer*, and *The Hague Journal of Diplomacy*, among others, and co-edited the volume *Comprehensive Peacebuilding on the Korean Peninsula: Internal Dynamics in North Korea and South Korean Approaches* (Palgrave Macmillan, 2023).

David Cheng Chang is Associate Professor of Humanities at the Hong Kong University of Science and Technology and Visiting Professor of History at Ewha Womans University. He was the Radcliffe-Harvard Yenching Institute Fellow at Harvard University in 2021–2022. He received his PhD in modern Chinese history from the University of California, San Diego. He studies the Cold War, US–China relations, and the social history of war and revolution as experienced by the common people, such as China's World War II interpreters and Korean War soldiers and prisoners. His first book, *The Hijacked War: The Story of Chinese POWs in the Korean War*, was published by Stanford University Press in 2020.

He holds a PhD in political science from the University of Toronto, an MA in global affairs and policy from Yonsei University, and a BA in political science from Harding University.

David P. Fields is Associate Director of the Center for East Asian Studies at the University of Wisconsin–Madison. He is the author of Foreign Friends: Syngman Rhee, American Exceptionalism, and the Division of Korea (University Press of Kentucky, 2019) and the editor of The Diary of Syngman Rhee, 1904–34, 1944 (National Museum of Korean Contemporary History, 2015). Since 2015 he has been the book review editor of the Journal of American-East Asian Relations.

Go Myong-hyun is Senior Research Fellow at the Asan Institute for Policy Studies. Previously, he was a postdoctoral researcher at the University of California, Los Angeles. His research applies quantitative perspectives to traditional and nontraditional security issues, with a special focus on North Korea, sanctions enforcement, and the security and strategic dimensions of technology. Dr. Go was a Munich Young Leader of the Munich Security Conference 2015 and is formerly a member of the Advisory Committee of the ROK Ministry of National Defense, Senior Adjunct Fellow at the Center for a New American Security, and Associate Fellow at the Royal United Services Institute. He received a PhD in policy analysis from the Pardee RAND Graduate School.

Fintan Hoey is Associate Professor of History at Franklin University Switzerland. He is the author of *Sato*, *America and the Cold War: U.S.-Japanese Relations*, 1964–1972, which was published by Palgrave

Macmillan in 2015. He was a Swiss National Science Foundation–funded Fellow at the Woodrow Wilson International Center for Scholars, Washington, DC, in Spring 2019. His current research is focused on Japanese policies regarding nuclear weapons and nuclear power.

Mitchell B. Lerner is Professor of History and Director of the East Asian Studies Center at The Ohio State University, where he is also Fellow at the Mershon Center for International Security Studies. He is the author of The Pueblo Incident: A Spy Ship and the Failure of American Foreign Policy (University Press of Kansas, 2002), which won the John Lyman Book Prize, and has published articles in many journals, including The Journal of East Asian Affairs, Diplomatic History, Diplomacy & Statecraft, The Seoul Journal of Korean Studies, and The Journal of Military History. He has been Fellow at the Miller Center for Public Affairs at the University of Virginia and held the Mary Ball Washington Distinguished Fulbright Chair at University College Dublin.

Kathleen Stephens served as US Ambassador to the Republic of Korea from 2008 to 2011, the first woman and first Korean speaker to serve in that position. Other overseas assignments included postings to China, former Yugoslavia, Portugal, Northern Ireland, where she was US Consul General in Belfast during the negotiations culminating in the 1998 Good Friday Agreement, and India, where she was US Chargé d'Affaires (2014–2015). She also held numerous policy positions at the Department of State and the White House, including acting Under Secretary of State for Public Diplomacy and Public Affairs (2012), Principal Deputy Assistant Secretary of State for East Asian and Pacific Affairs (2005–2007), Deputy Assistant Secretary of State for European and Eurasian Affairs (2003–2005), and National Security Council Director for European Affairs at the Clinton White House. She is currently the Director of the Korea Economic Institute of America.

Clint Work is Fellow and Director of Academic Affairs at the Korea Economic Institute of America. Before joining the institute, Clint was Fellow with the Stimson Center's 38 North program. Prior to joining Stimson, he was Assistant Professor at the University of Utah's Asia Campus in South Korea and a regular foreign policy writer for *The Diplomat* magazine's Koreas page. He holds a Ph.D. in international studies from the University of Washington and an MA in international relations from the University of Chicago, and his work focuses on the Korean peninsula, US–Korean relations, East Asia, and US foreign policy.
