SJEF BARBIERS is Professor of Dutch Linguistics at Leiden University. He was the leader of the Syntactic Atlas of the Dutch Dialects and European Dialect Syntax projects. He is currently the scientific director of the Leiden University Centre for Linguistics.

NORBERT CORVER is Professor of Dutch Linguistics at Utrecht University. He is co-editor of several books, including *Semi-lexical Categories* (with van Riemsdijk, 2001) and *Diagnosing Syntax* (with Cheng, 2013). He is currently the scientific director of Utrecht University Institute for Language Sciences.

MARIA POLINSKY is Professor of Linguistics at the University of Maryland and Director of the National Heritage Research Center at UCLA. She has served on the editorial boards of multiple journals and advisory boards of several international centres. She is the author of multiple scholarly articles and several books, and editor of several handbooks.

KLAUS ABELS is Professor of Linguistics at University College London, UK. His work focuses on the questions of what the universal properties of elliptical constructions are, whether there is syntactic structure at the ellipsis site, and how ellipsis interacts with syntactic displacement. He is also very interested in universal properties of word order. He addresses these questions within the Chomskyan tradition in linguistics. He is the author of *Phases: An Essay on Cyclicity in Syntax* (2012) and co-editor of *Syntax: A Journal of Theoretical, Experimental and Interdisciplinary Research.*

ARTEMIS ALEXIADOU is Director of the Leibniz-Centre General Linguistics (ZAS) in Berlin and Professor of General Linguistics at the Humboldt University of Berlin, Germany. Her research focuses on the syntax-morphology interface, argument structure alternations, and the structure of noun phrases. Her publications include *Functional Structure in Nominals: Nominalization and Ergativity* (2001) and *External Arguments in Transitivity alternations* (co-authored with Elena Anagnostopoulou and Florian Schäfer, 2015). She was awarded the prestigious Gottfried Wilhelm Leibniz Prize by the German Research Foundation in 2014.

SJEF BARBIERS is Professor of Dutch Linguistics at Leiden University, The Netherlands. His work focuses on (micro-)comparative syntax from a theoretical perspective. He was Principal Investigator of the Syntactic Atlas of the Dutch Dialects (SAND) and the European Dialect Syntax (EDISYN) project, co-author of the *Syntactic Atlas of the Dutch Dialects*, Volumes 1 and 2, and coeditor of *Microvariation in Syntactic Doubling*. He has published on the morphosyntax of numerals, noun phrases, focus particles, adverbs, questionword questions, imperatives, and verbs.

BALTHASAR BICKEL is Professor of General Linguistics at the University of Zurich and Director of Switzerland's national research center on evolutionary

language science, the NCCR Evolving Language. Grounded in fieldwork and typology, he uses a variety of experimental and data-science methods to uncover the cultural and biological forces that shape language evolution. In recent years he has mainly published in interdisciplinary (e.g., *Science*, *PNAS*), biological (e.g., *PloS Biology*, *Neurobiology of Language*), linguistic (e.g., *Language*, *Diachronica*), psycholinguistic (e.g., *Brain and Language*, *Language*, *Cognition and Neuroscience*), and cognitive science (e.g., *Cognitive Science*, *Open Mind*) venues.

LISA LAI-SHEN CHENG is Professor of General Linguistics at Leiden University, The Netherlands. Her work focuses on comparative syntax, the syntax-semantics, syntax-prosody, and syntax-processing interfaces. She was the Principal Investigator of an EU project on multilingualism (AThEME) and a Dutch project, *Understanding Questions*.

EMILY CLEM is an Assistant Professor of Linguistics at the University of California, San Diego, USA. She received her PhD in linguistics from the University of California, Berkeley. Her research focuses on topics including agreement, case, and switch-reference, with an emphasis on bringing data from understudied languages to bear on syntactic theory.

NORBERT CORVER is Professor of Dutch Linguistics at Utrecht University, The Netherlands. His research interests include Dutch syntax, comparative syntax, and the language-affect interface. He is co-editor of seven books, including *Semi-Lexical Categories* (2001) and *Diagnosing Syntax* (2013), co-editor of the book series *Studies in Generative Grammar* (De Gruyter Mouton) and *Comprehensive Grammar Resources* (Amsterdam University Press), and co-author of *Syntax of Dutch: Verbs and Verb Phrases* (Vol. 1–3; 2015–2016) and *Syntax of Dutch: Coordination and Ellipsis* (2019).

JEROEN VAN CRAENENBROECK is Professor of Dutch Linguistics at KU Leuven, Belgium, and senior researcher on variation linguistics at the Meertens Institute in Amsterdam, The Netherlands. He is an internationally recognized expert on morphosyntactic variation in varieties of Dutch and has published three books and more than forty-five papers in peer-reviewed journals and edited volumes. In recent years, he has explored the interaction between theoretical syntax on the one hand and the statistical analysis of large-scale collections of native-speaker judgments on the other.

VENEETA DAYAL is Professor of Linguistics at Yale University, New Haven, USA. She works on semantics and the syntax-semantics interface, typically from a cross-linguistic perspective. She is the author of *Locality in Wh Quantification: Questions and Relative Clauses in Hindi* (1995) and *Questions* (2016), co-editor of *Clause Structure in South Asian Languages* (2004), and editor of the forthcoming *The Open Handbook of (In)definiteness:*

ÉVA DÉKÁNY is a senior researcher at Hun-Ren Hungarian Research Centre for Linguistics in Budapest, Hungary. Since 2022 she has also been a part-time senior researcher at the Centre for Theoretical Linguistics, Eötvös Loránd University, also in Budapest. Her work focuses on nominal and adpositional structures. She is author of the book *The Hungarian Nominal Functional Sequence* (2021).

HAMIDA DEMIRDACHE is Professor of Linguistics and head of the Linguistic Lab at the University of Nantes, France. Her research combines theoretical and experimental linguistics to explore issues at the syntax-semanticsacquisition interfaces: How do syntax and semantics map onto each other (LF-syntax)? How do children learn the inherently abstract concepts (logical operators, tense ...) that all languages convey while showing astonishing variation in their morphosyntactic encoding?

MARCEL DEN DIKKEN is Research Professor at Eötvös Loránd University and Senior Researcher at the Hungarian Research Centre for Linguistics in Budapest, Hungary. He is the editor of *The Cambridge Handbook of Generative Syntax* (2013), the (co-)editor of several volumes and special issues of journals, the author of four monographs, and co-author of *Syntax of Dutch: Nouns and Noun Phrases* (Vol. 2, 2012). He has published over a hundred articles in peer-reviewed journals and edited volumes and encyclopedias. His research covers a wide variety of aspects of syntax and its interfaces with morphology and semantics.

BRIAN DILLON is an Associate Professor in the Department of Linguistics at the University of Massachusetts, Amherst, USA. He specializes in psycholinguistics. His research focuses on the cognitive mechanisms that underlie syntactic processing in adults. In his research, he uses experimental methods such as eye-tracking-while-reading to investigate the relationship between language and memory across grammatically diverse languages.

DAVID EMBICK is Professor of Linguistics at the University of Pennsylvania, USA. His work addresses a number of core areas in linguistic theory, with a special emphasis on morphosyntax, with an experimental dimension in addition. He is one of the leading experts in Distributed Morphology.

MARTIN EVERAERT is Emeritus Professor of Linguistics, Utrecht University, The Netherlands. He works on the syntax-semantics/lexicon interfaces, language evolution, and sociolinguistics. He has co-authored work on Indo-European, Austronesian, Sino-Tibetan, and Austroasiatic languages. He is series editor of the Wiley-Blackwell Companions to Linguistics. His

co-editorial works include *The Wiley-Blackwell Companion to Syntax* (2017), *The Use of Databases in Cross-Linguistic Studies* (2009), *Concepts, Syntax and Their Interfaces* (2016), *Birdsong, Speech and Language* (2013) and a special issue "The Biology of Language" in *Neuroscience & Biobehavioral Reviews.*

PAULA FENGER is currently a postdoctoral researcher at Leipzig University, Germany. She received her PhD from the University of Connecticut, USA, with a dissertation on words cross-linguistically, by focusing on their phonological, morphological, and syntactic aspects. She has published work in *Natural Language & Linguistic Theory* and the *Journal of Comparative Germanic Linguistics*.

SUZANA FONG has a PhD from the Massachusetts Institute of Technology, USA, and an MA degree from University of São Paulo, Brazil. Her research focuses on different types of A-dependencies across finite and nonfinite clauses, especially hyperraising and control. Her work has been featured in *Glossa* and *Syntax*.

ROBERT FRANK is Professor of Linguistics at Yale University, USA. His research looks at syntax using computational and mathematical tools, with the goal of characterizing grammatical universals in formal terms. His work in the Tree Adjoining Grammar formalism (*Phrase Structure Composition and Syntactic Dependencies*, 2002) demonstrates the explanatory potential of imposing precisely defined computational limits on grammatical operations. Much of his recent work explores the virtues and vices of large language models as theories of linguistic knowledge.

MARIA TERESA GUASTI is Professor at the University of Milano-Bicocca, Italy. Her research focuses on language acquisition (typical development, children with language disorders, with dyslexia, bilingualism), on the relation between language and music, and the use of technology in promoting language acquisition among children with learning disadvantages. She has been awarded grants from the European Commission and is author of more than a hundred articles in peer-reviewed journals and four books, including *The Acquisition of Italian* (2015) with Adriana Belletti, and *Language Acquisition: The Growth of Grammar* (2017, 2nd edition).

CLAIRE HALPERT is an Associate Professor of Linguistics at the University of Minnesota, Twin Cities, USA. Her work has focused on topics including the syntax of case, agreement, A-movement, and clausal embeddings and the morphosyntactic expression of counterfactuality. She has conducted extensive research on the Bantu language Zulu and explored the role that case and agreement play in the language in her 2015 book, *Argument Licensing and Agreement*.

FATIMA HAMLAOUI is an Associate Professor of French Linguistics at the University of Toronto, Canada. Her main expertise is in the relationship

between syntax, pragmatics, and phonology within and across languages. She is known for her work on focus in declarative sentences and *wh*-questions, including in French, her native language. She also specializes in the study of Bantu languages, with a special interest in word order variation and the relationship between syntactic and phonological structure. JESSICA K. IVANI is a postdoctoral researcher in typology at the University of Zurich, Switzerland. Her main interests include typological data structuring, database design, language documentation, areal studies, and micro and macro linguistic variation. She focuses on Tibeto-Burman languages in her research.

PETER JENKS is an Associate Professor at the University of California, Berkeley, USA. His research focuses on cross-linguistic variation, particularly in the nominal domain and at the interfaces of syntax with semantics and phonology. He is also actively involved in the description of understudied languages of sub-Saharan Africa and Southeast Asia.

MAAYAN KESHEV is an Assistant Professor in the Linguistics Department at the Hebrew University of Jerusalem, Israel. She specializes in psycholinguistics and experimental linguistics. Her research focuses on the processing of syntactic dependencies and uses various experimental methods from acceptability and final interpretation to eye-tracking and cognitive modeling. In her research, Maayan tries to understand how adult comprehenders apply their grammatical knowledge word-by-word and how memory mechanisms and probabilistic knowledge affect this process. She has published on the processing of extraction, agreement, and anaphora.

MARJO VAN KOPPEN is Professor of Language Variation of Dutch at Utrecht University and senior researcher and team leader of the variation linguistics group at the Meertens Institute in Amsterdam, The Netherlands. She is an internationally recognized expert on the morphosyntactic variation of Dutch, Dutch dialects, and seventeenth-century Dutch. She has published in peerreviewed journals and edited volumes. Her research often involves the interface between formal linguistics and other disciplines like sociolinguistics and literary studies. Together with Jeroen van Craenenbroeck, she explores the

interaction between theoretical syntax and the statistical analyses of large-scale collections of native-speaker judgments.

MARIA KOUNELI is an Assistant Professor of Linguistics at Rutgers University, USA. She works primarily on syntax, morphology, and their interface, with an empirical focus on Nilotic languages. She received her PhD from New York University, and her work has appeared in journals such as *Natural Language & Linguistic Theory* and *Language*.

ADAM LEDGEWAY is Distinguished Professor at the University of Bergamo, Italy. He was formerly Professor of Italian and Romance Linguistics at the University of Cambridge, UK. His research interests include comparative syntax, language change and variation, and dialectology. Recent books include *Grammatica diacronica del napoletano* (2009), *The Cambridge History of the Romance Languages* (2011–13), *From Latin to Romance: Morphosyntactic Typology and Change* (2012); *The Oxford Guide to the Romance Languages* (2016), *The Cambridge Handbook of Historical Syntax* (2017), *Periphrasis and Inflexion in Diachrony* (2022), and *The Cambridge Handbook of Romance Linguistics* (2022).

AD NEELEMAN is Professor of Linguistics at University College London, UK. He received his PhD from Utrecht University, The Netherlands, in 1994 and has since published on a range of topics, including word order phenomena, the syntax-morphology interface, phrase structure theory, and the encoding of syntactic dependencies. Some of his recent projects are a paper (with Peter Ackema) on 2-1-3 orders in Dutch verb clusters (*Journal of Comparative Germanic Linguistics*, to appear), articles (with Joy Philip, Misako Tanaka, and Hans van de Koot) on the syntax of coordination (*Syntax*, 2023, and *Language*, to appear), an article (with Zoë Belk and Joy Philip) on right-node raising (*Linguistic Inquiry*, 2023), and an ever-expanding manuscript on the placement of adverbials in SVO languages.

MARK NORRIS received his PhD in linguistics from the University of California, Santa Cruz, USA. His research focuses on theoretical questions related to nominal morphosyntax, using both typological investigations and in-depth studies of individual languages, especially Icelandic and Estonian. He has authored or co-authored journal articles that appeared in *Linguistic Inquiry*, *Natural Language & Linguistic Theory*, and *Glossa*, among others. He was previously an Assistant Professor of Linguistics at the University of Oklahoma, USA, but he now works as a linguist in the tech industry in San Francisco.

ELENA PAGLIARINI received her PhD from the University of Milano-Bicocca, Italy. In 2023, she joined the Centre de Lingüística Teòrica at the Universitat Autònoma de Barcelona, Spain, where she carries out investigations on

language acquisition. She studies how children face the challenge of mapping word forms/sentences into meaning. In her research, she asks how children learn to interpret structures that contain inherently abstract operators, such as logical connectives and quantifiers. POLINA PLESHAK is a graduate student at the University of Maryland, College Park, USA. The main goal of her research is refining current syntactic theory with data from understudied languages. She combines a broad typological background and new theoretical trends. She also has substantial fieldwork experience. She has contributed several chapters to recent Moksha and Hill Mari grammars.

MARIA POLINSKY is Professor of Linguistics at the University of Maryland, College Park, and Director of the National Heritage Language Research Center at UCLA, USA. Her research interests include syntax theory, language universals, and cross-linguistic variation, as well as heritage languages and their impact on linguistic theory. She has worked on such topics as the syntax of long-distance dependencies, ergativity, verb-initial orders, and the syntaxinformation-structure interface. She is the editor/co-editor of several books, including *The Oxford Handbook of Languages of the Caucasus* (2020) and *The Cambridge Handbook of Heritage Languages and Linguistics* (2021), and the author of several books, including *Deconstructing Ergativity* (2016) and *Heritage Languages and Their Speakers* (2018).

PAUL PORTNER is a formal semanticist and specialist in the theories of the syntax-semantics and semantics-pragmatics interfaces. He has published articles and books on a variety of topics in these fields, including clause types,

mood, modality, tense, aspect, and allocutivity. He is Professor of Linguistics at Georgetown University, USA.

His research focuses on different aspects of the syntax and semantics of sign languages, Romance languages, and Greek. His research is inspired by the Minimalist Program and issues in the evolution of language, focusing on the nature of anaphoric dependencies as a window on the cognitive systems underlying language and their interaction, see *Anaphora and Language Design* (2011), "Language and Imagination: Evolutionary Explorations" (*Neuroscience & Biobehavioral Reviews*, 2017), and a variety of further contributions in edited volumes and journals, including *Linguistic Inquiry, Cognition, Glossa*, and *Studia Linguistica*.

ELIZABETH RITTER is Professor of Linguistics at the University of Calgary, Canada. She specializes in theoretical syntax and the relationship between syntax and other components of grammar. She has a long-standing interest in the structure of nominals, and currently leads a project, together with Martina Wiltschko, on nominal speech acts. Their contribution to this volume draws on the project's recent findings.

IAN ROBERTS obtained a BA in linguistics with a French minor from the University of Wales, UK, in 1979. He got his PhD in 1985 from the University of Southern California, USA. From 1985 to 1991, he taught at the University of Geneva in Switzerland. In 1991 he returned to the University of Wales, Bangor, as Professor of Linguistics. From 1996 to 2000 he was Professor of English Linguistics at the University of Stuttgart, Germany. He has been in Cambridge, UK, since 2000.

RADEK ŠIMÍK is Associate Professor in Linguistics at Charles University, Prague, Czech Republic. He is an expert in theoretical and experimental syntax and semantics. His particular interests include *wh*-constructions, questions, relative clauses, information structure, and nominal reference. He has published on Slavic, Germanic, and Bantu, but often also takes a comparative typological perspective. His research has appeared in *Language, Journal of*
