Drawing from the work of experienced scholars across various fields, countries, and periods, this volume is the first book in any language to provide a comprehensive history of antifascisms in Latin America and the Caribbean. It presents antifascism as a multifaceted phenomenon at the intersection of local, national, and transnational processes that is embraced by a variety of actors with differing agendas. Offering an innovative and fundamental contribution to several bodies of scholarship, including history, art, literature, sports, race, gender, and sexuality, it expands the field of antifascist studies by demonstrating the differences and similarities between Latin American and Caribbean movements and actors and their counterparts elsewhere. Multidisciplinary and accessible, the chapters in this volume will engage a broad audience and offer important insights about the rise of right-wing populism today.

SANDRA MCGEE DEUTSCH is Professor Emerita of History at the University of Texas at El Paso. She has authored multiple books on fascism and antifascism, including *Las Derechas: The Extreme Right in Argentina, Brazil, and Chile, 1890–1939* and *Gendering Antifascism: Women's Activism in Argentina and the World, 1918–1947*, which won the 2024 RMCLAS Thomas McGann Award.

JORGE A. NÁLLIM is Professor of History at the University of Manitoba. He specializes in the political, cultural, and intellectual history of modern Latin America and Argentina. He is the author of *Transformations and Crisis of Liberalism in Argentina, 1930–1955* and *Las raíces del antiperonismo: Orígenes históricos e ideológicos*. He has also published on Latin American antifascism and the cultural Cold War in Mexico, Chile, and Argentina.

Sandra McGee Deutsch is Professor Emerita of History at the University of Texas at El Paso. She is the author of *Gendering Antifascism: Women's Activism in Argentina and the World, 1918–1947* (University of Pittsburgh Press, 2023, recipient of RMCLAS 2024 Thomas McGann book award); *Crossing Borders, Claiming a Nation: A History of Argentine Jewish Women, 1880–1955* (Duke University Press, 2010, Argentine edition 2018, recipient of LAJSA 2011 book award); *Las Derechas: The Extreme Right in Argentina, Brazil, and Chile, 1890–1939* (Stanford University Press, 1999, Argentine edition 2005); and *Counterrevolution in Argentina, 1900–1932: The Argentine Patriotic League* (University of Nebraska Press, 2003, Argentine edition 2003). Jorge A. Nállim is Professor at the University of Manitoba's Department of History. He is the author of *Transformations and Crisis of Liberalism in Argentina, 1930–1955* (University of Pittsburgh Press, 2012) and *El anti-peronismo: Orígenes, históricos e ideológicos* (Capital Intelectual, 2014). His research focuses on modern Latin America and Argentina in the fields of political, cultural, and intellectual history. He has additionally published articles and chapters and coedited special journal issues on topics such as Argentine liberalism, antifascism, Peronism, and human rights, the Latin American cultural Cold War, and cultural and intellectual networks in Argentina, Mexico, and Chile.

Sandra Pujals is a professor of history at the University of Puerto Rico. She has an MA in Russian Area Studies and a PhD in Russian History, both from Georgetown University in Washington, DC. Her main research

interests include Soviet revolutionary culture, Caribbean transnational networks, and the transnational roots of Soviet Russia's cultural relationship with Latin America and the Caribbean (1920s–1940s), particularly through the Comintern. Her recent publications include chapters in collections for Routledge; Slavica Publishers; Manchester University Press; and McGill-Queen's University. Her book *Un Caribe soviético: El comunismo internacional en Puerto Rico y el Caribe* (Ediciones Complutense, 2022) was recently awarded the *Sello de calidad en edición académica* (Academic Publishing Quality Stamp) by the Union of University Presses of Spain (2023). She is currently working on another book titled *Su Casa Es Mi Casa: The Caribbean Bureau of the Comintern and the Forging of a Soviet Caribbean, 1930–1936*.

John Lear is Professor Emeritus of History and Latin American Studies at the University of Puget Sound. He was a visiting professor at the Universidad Autónoma de México-Iztapalapa and the Universidad de Campinas of Brazil and has held research residencies at the Center for US–Mexican Studies, the Hoover Institution, the Instituto de Bellas Artes in Mexico, and the Institute for Advanced Studies, Nantes. His books include *Chile's Free-Market Miracle: A Second Look* (Institute for Food and Development Policy, 1995); *Workers, Neighbors and Citizens: The Revolution in Mexico City* (University of Nebraska Press, 2001); and *Picturing the Proletariat: Artists and Labor in Revolutionary Mexico, 1908–1940* (University of Texas Press, 2017), available in Spanish as *Imaginar el Proletariado* (2019). He contributed two essays, “Diego Rivera Paints the Proletariat” and “The Red Squares of Manhattan,” for the SF MoMA exposition catalog *Diego Rivera's America* (2022). He is currently writing a political biography of Diego Rivera.

Pedro Cameselle-Pesce is an associate professor of history and an affiliated faculty of the Latin American Studies program at Western Washington University. His research investigates the interrelated roles of culture, social networks, and regional politics in US–Latin American relations during World War II. He is the coeditor of *Uruguay in Transnational Perspective* (Routledge, 2023). He has also published several essays on regional anti-fascist movements, including “Hugo Fernández Artucio and the Language of Democracy in Uruguay During World War II” (*Oxford Research Encyclopedia of Latin American History*, 2022) and “Italian-Uruguayans for Free Italy: Serafino Romualdi's Quest for Transnational Anti-Fascist Networks during World War II” (*The Americas*, 2020).

Vanesa Miseres is Associate Professor in the Department of Romance Languages and Literatures at the University of Notre Dame. She specializes in nineteenth- and early twentieth-century Latin American literature and culture. Her areas of research are travel writing, war literature, women writers, and gender, cultural, and food studies. She is the author of *Mujeres en tránsito: Viaje, identidad y escritura en Sudamérica (1830–1910)* (North Carolina Studies in the Romance Languages and Literatures, 2017) and coeditor of *Food Studies in Latin America. Perspectives on the Gastronomical Narrative* (University of Arkansas Press, 2021). Her work has appeared in academic journals such as *Chasqui*, *MLN*, *Letras Femeninas*, *Revista de Estudios Hispánicos*, *Arizona Journal of Hispanic Cultural Studies*, *Latin American Research Review*, and *Revista Hispánica Moderna*, among others. She has been awarded a Mendel fellowship, a Notre Dame Global Gateway Faculty Research award, and a Humboldt fellowship to support research for her forthcoming book *Gender Battles. Latin American Women, War, and Feminism* (University of Toronto Press).

Patricia Harms is Associate Professor of History and a Latin American scholar with a research focus on women in Guatemala and Central America. At Brandon University, she teaches a variety of courses focused on history in the Global South. Her monograph entitled *Ladina Social Activism in Guatemala City, 1871–1954* (University of New Mexico Press, 2020) focuses on the rise of feminist and women's social movements during the first half of the twentieth century. Her current project involves collecting testimonials from Spanish-speaking migrant women. She is also working with the Island Lake Tribal Council in collecting historical documents and elder oral stories. She received a Social Sciences and Humanities Research Council grant in 2021 to support this work.

Aaron Coy Moulton is Associate Professor of Latin American History at Stephen F. Austin State University. His current project, *Caribbean Blood Pacts: The Guatemalan Revolution and the Caribbean Basin's Cold War*, reveals how Guatemalan reactionaries, Caribbean Basin dictators, transnational corporations, and British intelligence put into motion what would become the United States government's notorious operations that overthrew Guatemala's democratically elected government in the early 1950s.

Ariel Mae Lambe is Associate Professor of History at the University of Connecticut Waterbury campus, where she teaches Latin American,

Caribbean, and US history classes. She has published and spoken on different aspects of Cuban antifascism – including interpretations of domestic fascism, antifascist transnationalism, and Cuban volunteers in Spain – and is the author of *No Barrier Can Contain It: Cuban Antifascism and the Spanish Civil War* (University of North Carolina Press, 2019). One of her current research projects, stemming from her September 2022 *American Historical Review* essay “Seeing Madness in the Archives,” deals with topics of silences, ableism, and mental illness. Her other current work-in-progress examines the concept of plausible deniability in international relations and US public perceptions of the Bay of Pigs invasion.

Dr. Cara K. Snyder (she/they) is Assistant Professor of Women’s, Gender, and Sexuality Studies at the University of Louisville. They have also taught at the federal and state universities in Bahía and Pernambuco, Brazil. Snyder earned a PhD from the Harriet Tubman Department of Women’s, Gender, and Sexuality Studies, with certificates in Teaching and Learning and Digital Studies, at the University of Maryland, College Park where they also completed a postdoctoral fellowship in the Latin American and Caribbean Studies Center. Snyder’s scholarly work has been published in peer-reviewed journals such as *WSQ: Women’s Studies Quarterly*, *Ada: A Journal of Gender, New Media and Technology*, *International Journal of Women’s Studies*, and *The Radical Teacher*. Currently, Snyder is working on a book about visibility, gender dissidence, and the struggles of women and LGBTQ+ athlete-activists for the right to play Brazilian soccer.
