This volume provides an illuminating exploration of how ideas about whiteness have shaped the literature and culture of the United States. Covering nearly 250 years – from the 1790 Naturalization Act, which limited access to citizenship to immigrants who were “free white person[s],” to the present – *Whiteness and American Literature* considers how a broad spectrum of novels, movies, short stories, television shows, poems, songs, and other works depict whiteness. The collection’s twenty accessible and engaging chapters by renowned scholars analyze representations of whiteness in a variety of historical periods, literary genres, and aesthetic forms. Chapters also survey scholarly work at the crossroads of whiteness studies and disability studies, food studies, and other academic disciplines. Designed for scholars, students, and general readers, this book is essential reading for anyone interested in gaining a deeper understanding of the role whiteness plays in the US imagination.

Contributors

MITA BANERJEE is a professor of American studies at the Obama Institute for Transnational American Studies at the University of Mainz, Germany. She specializes in comparative ethnic American literature, with an emphasis on health justice, whiteness, and citizenship. She is the author of *Color Me White: Naturalism/Naturalization in American Literature* (2013) and *Medical Humanities in American Studies* (2018). She is a member of the collaborative research unit Human Differentiation and co-speaker of the research training group Life Sciences, Life Writing: Boundary Experiences of Human Life between Biomedical Explanation and Lived Experience, both funded by the German Research Foundation.

LEE BEBOUT is a professor of English at Arizona State University. Bebout teaches on and researches in the areas of race, social justice, and political culture. He has authored two books, and his articles have appeared in *Aztlán*, *MELUS*, *Latino Studies*, and other scholarly journals. His book *Whiteness on the Border: Mapping the US Racial Imagination in Brown and White* (2016) examines how representations of Mexico, Mexicans, and Mexican Americans have been used to foster whiteness and Americanness, or more accurately whiteness as Americanness. He is currently completing a book on reactionary rhetorical strategies.

EDWARD K. CHAN is a professor of American studies at Waseda University in Japan. His research and teaching interests cut across transnational perspectives on American culture in relation to race and utopia. Selected publications include *White Power and Neoliberal American Culture* (2023, coauthor), “Race” (*Palgrave Handbook of Utopian and Dystopian Literature*, 2022), “Race in the *Blade Runner* Cycle and Demographic Dystopia” (2020), “The White Power Utopia and the Reproduction of Victimized Whiteness” (2019, also coeditor), *The Racial Horizon of*

Utopia (2016), and “Utopia and the Problem of Race” (2006). He also coedited a special issue of *Utopian Studies* on race (2019).

ANDREW DONNELLY is an assistant professor of English at the University of Memphis. His writing on nineteenth-century American literature, Civil War–era culture, and the history of sexuality has appeared in *Civil War History*, *American Literary History*, *Women’s Studies*, and *Public Books*. His book *Confederate Sympathies: Same-Sex Romance, Disunion, and Reunion in the Civil War Era* (2025) explores how depictions of same-sex romance cultivated sympathy for the Lost Cause.

JOHN ERNEST is the Judge Hugh M. Morris Professor and the chair of the English department at the University of Delaware. He is the author of over forty-five essays and author or editor of thirteen books, including *Liberation Historiography: African American Writers and the Challenge of History, 1794–1861* (2004), *Chaotic Justice: Rethinking African American Literary History* (2009), *The Oxford Handbook of the African American Slave Narrative* (2014), and *Race in American Literature and Culture* (2022).

TERESA A. GODDU is a professor of English at Vanderbilt University. She is the author of *Gothic America: Narrative, History, and Nation* (1997) and *Selling Antislavery: Abolition and Mass Media in Antebellum America* (2020). She currently writes on contemporary US climate fiction.

JUSTIN GOMER is an associate professor of American studies at California State University, Long Beach. He is the author of *White Balance: How Hollywood Shaped Colorblind Ideology and Undermined Civil Rights* (2020), which was named one of “The Best Black History Books of 2020” by the African American Intellectual History Society. In addition, his work appears in the *Journal of Sport and Social Issues*, *Souls: A Critical Journal of Black Politics, Culture and Society*, the *Washington Post*, *Boston Review*, and *Black Perspectives*, among others.

T. AUSTIN GRAHAM is an associate professor of English and comparative literature at Columbia University. He is the author of *The Great American Songbooks: Musical Texts, Modernism, and the Value of Popular Culture* (2013). Presently, he is writing a book on American historical fiction and the phenomenon of historical ignorance.

TIMOTHY HELWIG is a professor of English at Furman University. His monograph *Cross-Racial Class Protest in Antebellum American Literature* was published by the University of Massachusetts Press in 2020, and his articles have appeared in *American Studies*, *American Periodicals*,

STEPHEN KNADLER is a professor of English and the chair of the English department at Spelman College. He is the author of *The Fugitive Race: Minority Writers Resisting Whiteness* (2002), *Remapping Citizenship and the Nation in African American Literature* (2009/10), and *Vitality Politics: Health, Debility, and the Limits of Black Emancipation* (2019), which won the Tobin Siebers Prize for Disability Studies in the Humanities. He is currently working on a project tentatively entitled *Counterintelligences: Early Black Disability Politics and the Disordering of Liberal Humanism*.

JORIE LAGERWEY and TAYLOR NYGAARD are a writing partnership invested in studying race, gender, class, and genre. Their work mobilizes industry studies, feminist criticism, critical race studies, whiteness studies, discourse of celebrity, and TV style. They are the authors, most recently, of *Horrible White People: Gender, Genre, and Television’s Precarious Whiteness* (2020).

STEPHANIE LI has published six books including the award-winning *Something Akin to Freedom: The Choice of Bondage in Narratives by African American Women* (2010), as well as *Signifying without Specifying: Racial Discourse in the Age of Obama* (2011), *Playing in the White: Black Writers, White Subjects* (2015), and *Signifyin(g) Immigrants: Twenty-First Century Pan-African American Literature* (2018). She has also

written two short biographies of Toni Morrison and Zora Neale Hurston. Her latest book, published by the University of Minnesota Press, is entitled *Ugly White People: Whiteness in Contemporary American Literature* (2023).

MARVIN MCALLISTER is an associate professor of theater at Winthrop University. He is the author of two books, *White People Do Not Know How to Behave at Entertainments Designed for Ladies and Gentlemen of Colour: William Brown's African and American Theater* (2003) and *Whiting Up: Whiteface Minstrels and Stage Europeans in African American Performance* (2011). He has worked as a dramaturg, literary manager, and playwright for theater companies in New York City, Washington, DC, Chicago, and Seattle. Professor McAllister is currently developing an adaptation of William Wells Brown's *The Escape; or, A Leap for Freedom*.

HANNAH LAUREN MURRAY teaches at the University of Melbourne and is an honorary research fellow at the University of Liverpool. She has also published on whiteness in the *Irish Journal of Gothic and Horror Studies* (2017), *The Oxford Handbook of Charles Brockden Brown* (2019), *English: Journal of the English Association* (2021), and *Crossings in Nineteenth-Century American Culture* (2022).

EDEN OSUCHA is an associate professor of English at Bates College, where her research and teaching focus on race, sexuality, and citizenship in American literature, law, and visual culture. Her scholarship has appeared in *American Literary History*, *Camera Obscura*, several collections, and a special issue of *American Literature* on critical pedagogy, which she coedited.
