

Invisible Revolutionaries

Invisible Revolutionaries sheds light on the critical role women play in a contemporary revolution. The book argues that women's engagement in contentious politics is often far less visible than men's participation, when measured by the physical presence of women in protest space. Using the case of the 2013–2014 Revolution of Dignity in Ukraine, the book outlines the different modes of women's participation in a revolution and illustrates how women can be at the forefront of civil resistance, fighting for national independence and democratic development. Drawing on data from large-N surveys and oral history projects, the book uncovers the diverse motivations and forms of women's involvement in mass mobilization and traces the multifaceted outcomes of their activism in the post-revolutionary period. The book proposes an original typology of women's engagement in a revolution and explores a pivotal moment in Ukraine's history that precedes the Russia–Ukraine War.

Olena Nikolayenko is a professor of political science at Fordham University and an associate at the Davis Center for Russian and Eurasian Studies at Harvard University. She is also a board member of the American Association for Ukrainian Studies and the Shevchenko Scientific Society in the United States. Her research has appeared in Comparative Politics, International Journal of Sociology, International Political Science Review, International Sociology, Slavic Review, Social Movement Studies, and other journals.

The idea for this book was conceived during Ukraine's Revolution of Dignity, and the importance of telling women's stories and preserving national history has become even more acute since the onset of Russia's brutal war against Ukraine in 2014. Over the past century, Ukrainian women exhibited a great deal of resilience and resourcefulness in fighting for Ukraine's national independence, democratic development, and cultural heritage. This book is dedicated to unsung heroines of the Ukrainian liberation struggle from the early twentieth century to the present day.
