The Cambridge History of American Poetry offers a comprehensive exploration of the development of American poetic traditions from their beginnings until the end of the twentieth century. Bringing together the insights of fifty distinguished scholars, this literary history emphasizes the complex roles that poetry has played in American cultural and intellectual life, detailing the variety of ways in which both public and private forms of poetry have met the needs of different communities at different times. The Cambridge History of American Poetry recognizes the existence of multiple traditions and a dramatically fluid canon, providing current perspectives on both major authors and a number of representative figures whose work embodies the diversity of America's democratic traditions.

ALFRED BENDIXEN teaches American literature at Princeton University and is the founder and Executive Director of the American Literature Association. His earlier scholarship emphasized the recovery of unjustly neglected literary texts and the exploration of neglected genres, but his current focus is on the role of genre in democratic culture. His most recent books include A Companion to the American Novel (2012); A Companion to the American Short Story (2010), co-edited with James Nagel; and The Cambridge Companion to American Travel Writing (2009), co-edited with Judith Hamera.

STEPHEN BURT is Professor of English at Harvard University. His books of literary criticism and scholarship include *The Art of the Sonnet* (2010), with David Mikics; *Close Calls with Nonsense* (2009), a finalist for the National Book Critics Circle Award; *The Forms of Youth: 20th-Century Poetry and Adolescence* (2007); and *Randall Jarrell and His Age* (2002), winner of the Warren-Brooks Award. He is also the author of three full-length books of poetry: *Belmont* (2013); *Parallel Play* (2006); and *Popular Music* (1999), winner of the Colorado Prize.

CHARLES ALTIERI has taught modern poetry for more than forty years, the last twenty at the University of California at Berkeley, where he is now Rachel Stageberg Anderson Professor of English. He has written numerous essays and nine books of criticism on theoretical topics and on twentieth-century American poetry, including *Act and Quality* (1981), *Self and Sensibility in Contemporary American Poetry* (1984), *Painterly Abstraction in Modernist American Poetry* (1989), *Canons and Consequences* (1991), *The Particulars of Rapture: An Aesthetics of the Affects* (2003), *The Art of Modernist American Poetry* (2005), and the forthcoming *Wallace Stevens and the Challenges of Modernity: Towards a Phenomenology of Value.*

Faith Barrett is Associate Professor of English at Duquesne University. She is the author of *To Fight Aloud Is Very Brave: American Poetry and the Civil War* (2012) and of articles on the poetry of Emily Dickinson, Herman Melville, and Abraham Lincoln. With Cristanne Miller, she co-edited *Words for the Hour: A New Anthology of American Civil War Poetry* (2005).

ALFRED BENDIXEN teaches American literature at Princeton University. He is the founder of the American Literature Association, of which he currently serves as Executive Director. His books include Haunted Women (1985); an edition of the composite novel The Whole Family (1986); an edition of "The Amber Gods" and Other Stories by Harriet Prescott Spofford (1989); and Edith Wharton: New Critical Essays (1992). He is the associate editor of The Continuum Encyclopedia of American Literature (1999), the co-editor of The Cambridge Companion to American Travel Writing (2009) and A Companion to the American Short Story (2010), and editor of A Companion to the American Novel (2012).

David Bergman, Professor of English at Towson University, is the author of *Gaiety Transfigured: Gay Self-Representation in American Literature* (1991) and *The Violet Hour: The Violet Quill and the Making of Gay Culture* (2004). He is also the author of two books of poetry: *Heroic Measures* (1998) and *Cracking the Code* (1985), winner of the George Elliston Poetry Prize. With Katia Sainson he has translated Jean Sénac's *Selected Poems* (2010).

Edward Brunner is Professor of American Literature at Southern Illinois University, Carbondale. His books include *Cold War Poetry: The Social Text in the Fifties Poem* (2004), W. S. Merwin: The Labor and Privilege of Poetry (1991), and Splendid Failure: Hart Crane and the Making of "The Bridge" (1985); his recent articles have appeared in MELUS, American Periodicals, Iowa Journal of Cultural Studies, and International Journal of Comic Art.

Her books include American Literature in Context to 1865 (2011), American Travel Writing and Empire (with David Seed, 2009), Colonial Encounters in New World Writing 1500–1786: Performing America (2005), and two books co-edited with Ivy Schweitzer, A Companion to the Literatures of Colonial America (2005) and The Literatures of Colonial America (2001). From 2005 to 2009 she edited the Journal of American Studies. She is also a published poet and literary translator.

MICHAEL C. COHEN is Assistant Professor of English at UCLA. He has written many essays on nineteenth-century poetry for journals such as *American Literature*, *Arizona Quarterly*, and *Victorian Poetry*, in addition to the entry "Poetry of the United States, Beginnings to 1900" for *The Princeton Encyclopedia of Poetry and Poetics* (2012). He is co-editor of *The Poetry of Charles Brockden Brown* (forthcoming) and is finishing a book, entitled *The Social Lives of Poems in Nineteenth-Century America*, that provides a material history of the ways people read, wrote, circulated, and otherwise used poems in early American culture.

ROBERT DALY, SUNY Distinguished Teaching Professor of English and Comparative Literature at the State University of New York at Buffalo, Leverhulme Fellow, and Guggenheim Fellow, has written *God's Altar: The World and the Flesh in Puritan Poetry* (1978), the introduction to the John Harvard Library edition of Cooper's *The Pioneers* (2011), and many articles and reviews published in *American Literature, Nineteenth-Century Fiction, American Literary History, Comparative Literature Studies*, and elsewhere.

BETTY BOOTH DONOHUE is an independent scholar and an enrolled member of the Cherokee Nation. She has written articles for the *American Indian Culture and Research Journal* and *Studies in American Indian Literature*. She contributed an essay on the Mvskogee poet Alexander Posey to the *Dictionary of Literary Biography* (1997) and a chapter entitled "Oktahutchee's Song" to *Teaching Nineteenth-Century American Poetry* (2007). Her latest work, *Bradford's Indian Book: Being the True Roote & Rise of American Letters as Revealed by the Native Text Embedded in Of Plimoth Plantation*, was published in 2011.

JIM EGAN is Professor of English at Brown University. He is the author of *Oriental Shadows: The Presence of the East in Early American Literature* (2011) and *Authorizing Experience: Refigurations of the Body Politic in Seventeenth-Century New England Writing* (1999). His other publications include essays on John Smith, eighteenth-century British-American mercantile poetry, Benjamin Franklin, and the wonder tale in early America. In addition to his scholarly publications, Professor Egan has published fiction.

RICHARD FLYNN, Professor of Literature at Georgia Southern University, is the author of Randall Jarrell and the Lost World of Childhood (1990). He has written essays on poets such as

ED FOLSOM is the editor of the Walt Whitman Quarterly Review, co-director of the Walt Whitman Archive (www.whitmanarchive.org), and editor of the Whitman Series at the University of Iowa Press. The Roy J. Carver Professor of English at the University of Iowa, he is the author or editor of twelve books, including Walt Whitman's Native Representations (1994) and (with Kenneth M. Price) Re-Scripting Walt Whitman (2005), as well as numerous essays on Whitman and other American writers appearing in journals such as American Literature, PMLA, and the Virginia Quarterly Review. He was featured in an episode of the PBS documentary American Experience (2008), and he is now working on a biography of Leaves of Grass.

STEPHEN FREDMAN is Professor of English and Concurrent Professor of American Studies at the University of Notre Dame. He is the author of *Poet's Prose* (1983, 1990), *The Grounding of American Poetry* (1993), *A Menorah for Athena* (2001), and *Contextual Practice* (2010). He has edited *A Concise Companion to Twentieth-Century American Poetry* (2005) and, with Steve McCaffery, *Form, Power, and Person in Robert Creeley's Life and Work* (2010).

Frank Gado is Professor Emeritus of English at Union College. He is currently working on a study of performance and celebrity in modernist American poetry, and he serves as editor of the electronic Whitman studies journal *The Mickle Street Review* and as associate editor of the *Robert Frost Review*.

Christoph Irmscher is Provost Professor of English at Indiana University—Bloomington. She is the editor of Volume D: 1914–1945 of The Norton Anthology of American Literature, and, with Martha Nell Smith, she co-edited A Companion to Emily Dickinson.

Wendy Martin is Professor of American Literature and American Studies at Claremont Graduate University, where she is also Vice Provost and Director of Transdisciplinary Studies and holds the George and Ronya Kozmetsky Endowed Chair of Transdisciplinary Studies. The author of numerous articles and reviews, she founded (in 1972) and continues to edit Women's Studies: An Interdisciplinary Journal. Her recent books include *Reading in Time: Emily Dickinson in the Nineteenth Century* (2012); *Cultures of Modernism: Marianne Moore, Mina Loy, and Else Lasker-Schüler*, a study of gender and literary community in New York and Berlin (2005); and *Marianne Moore: Questions of Authority* (1995), and she co-edited Moore's

Selected Letters (1997) and Feminist Measures: Soundings in Poetry and Theory (1994). She is currently preparing a new reader's edition of Emily Dickinson's complete poems.

Walton Muyumba is Associate Professor of American and African American literature at the University of North Texas. SIOBHAN PHILLIPS is Assistant Professor of English at Dickinson College. She is the author of *The Poetics of the Everyday: Creative Repetition in Modern American Verse* (2009). Her poetry and essays have appeared in *PMLA*, *Modernism/Modernity*, *The Los Angeles Review of Books, Boston Review, Harvard Review, Yale Review*, and other publications. She is working on a book about poetry and letters in the period from 1950 to 2000.

BRIAN M. REED is Professor of English at the University of Washington, Seattle.
