The face of the world is changing. The past century has seen the incredible growth of international institutions. How does the fact that the world is becoming more inter-connected change institutions' duties to people beyond borders? Does globalization alone engender any ethical obligations? In *Globalization and Global Justice* Nicole Hassoun addresses these questions and advances a new argument for the conclusion that there are many coercive international institutions. She argues that such institutions must enable their subjects to avoid severe poverty. She considers the case for aid and trade in light of these obligations, and concludes with a new proposal for Fair Trade in pharmaceuticals and biotechnology. Her book will appeal to readers in philosophy, politics, economics, and public policy.

NICOLE HASSOUN is Assistant Professor in Philosophy at Carnegie Mellon University. She has published articles in journals including the *American Philosophical Quarterly*, *The Journal of Applied Ethics*, *Public Affairs Quarterly*, *Environmental Ethics*, and *Utilitas*.
