Legacies of Stalingrad

Christina Morina's book examines the history of World War II on the Eastern Front and its impact on German politics and society throughout the postwar period. She argues that the memory of the Eastern Front was one of the most crucial and contested themes in each part of the divided Germany. Although the Holocaust over time gained the most prominent position in West German memory, official memory in East Germany centered on the war against the Soviet Union. Morina analyzes the ways in which these memories emerged in post-war German political culture during and after the Cold War and how views of these events played a role in contemporary political debates. Her analysis pays close attention to the biographies of the protagonists, both during and after the war, demonstrating that political memory was formed and informed as much by ideology and politics as by individual experience.

Christina Morina is a lecturer at the University of Jena, Germany. She received her doctorate in 2007 from the University of Maryland and has published several scholarly articles on issues of war, memory, and political culture in twentieth-century German history. She is currently writing a second book, which examines the relation between experience, ideology, and politics in the lives and works of leading Marxists (1870–1914). Morina is also the coeditor of a forthcoming comprehensive volume on the divided history of the German historical sciences since 1945. In 2009, she cofounded an International Young Scholars' Network on "The History of Societies and Socialisms."
