Suzanne served as a *référendaire* (legal adviser) in the cabinet of Advocate General Geelhoed at the European Court of Justice, Luxembourg from 2004 to 2006, and has been international visiting professor of law at Columbia Law School, New York.

Veerle Heyvaert is Associate Professor of Law (Reader) at LSE where she teaches and publishes on environmental law. Founding Editor-in-Chief of *Transnational Environmental Law*, she has worked as an attorney in Brussels and was Moragoda Professor of Public International Law (Sri Lanka 2015), Sir Peter North Fellow at the Oxford Centre for Socio-Legal Studies and Keble College, and a UNITAR Special Fellow.

Aleksandra Čavoški is a senior lecturer at the School of Law, University of Birmingham. She has over ten years of academic experience in civil and common law jurisdictions and was a key contributor to the development of EU legal studies in Serbia, in particular EU environmental studies. Her publications include research on environmental law in both English and Serbian. She was a visiting professor at Washington and Lee University School of Law (USA 2011).
