#### EDITORIAL NOTE

From the first volume to the fortieth, *Anglo-Saxon England* concluded with a comprehensive bibliography of publications across the wide range of Anglo-Saxon studies, which has become one of the most important of scholarly resources available to the practising Anglo-Saxonist. The remarkable expansion of the field over these forty years is reflected in the growth of the bibliography, and its compilation has in recent years become a considerable challenge. It has therefore been decided to reconceive the format of the bibliography, with effect from the present (forty-first) volume. The bibliography will no longer appear as part of the print volume, and the effort will be redirected towards the development of a cumulative online bibliographic resource, covering the period from *c*. 1970, which will take advantage of the many new opportunities brought about by electronic publication.

## PROFESSOR MECHTHILD GRETSCH

Professor Mechthild Gretsch, University of Göttingen, died in Munich on 14 March 2013, whilst this volume was at press. Her first article in the journal was published in the third volume (1974); her last is published in the present volume (2013). She had been a member of the editorial board since 2002.
