The Cambridge Companion to the United States Constitution

This Companion provides a broad, historically informed introduction to the study of the U.S. constitutional system. In place of the usual laundry list of constitutional clauses and doctrines, it presents a picture of the constitutional system in action, with separate sections devoted to constitutional principles, organizational structures, and the various legal and extra-legal “actions” through which litigators and average citizens have attempted to bring about constitutional change. Finally, the volume covers a number of subjects that are rarely discussed in works aimed at a general audience, but which are critical to ensuring that constitutional rights are honored in the day-to-day lives of citizens. These include standing and causes of action, suits against officeholders, and the inner workings of the Foreign Intelligence Surveillance Court (FISC). This Companion places present-day constitutional controversies in historical context, and offers insights from a range of disciplines, including history, political science, and law.

Karen Orren is Distinguished Professor of Political Science at UCLA. Her previous books with Cambridge University Press include *Belated Feudalism* and *The Search for American Political Development*, with Stephen Skowronek. Her most recent book, also with Stephen Skowronek, is *The Policy State*.

John W. Compton is Associate Professor of Political Science at Chapman University. He is the author of *The Evangelical Origins of the Living Constitution*.
