Featuring cutting-edge research from top scholars in the field, the chapters provide an overview of psychological models of prejudice; investigate prejudice in specific domains such as race, religion, gender, and appearance; and develop explicit, evidence-based strategies for disrupting the processes that produce and maintain prejudice. This handbook challenges researchers and readers to move beyond their comfort zone and sets the agenda for future avenues of research, policy, and intervention.

DR. CHRIS G. SIBLEY is a researcher in social psychology and founder of the New Zealand Attitudes and Values Study (NZAVS), a twenty-year long-itudinal national probability study of social attitudes, personality, and health outcomes across New Zealand. As an author of over 200 peer-reviewed articles and book chapters, he was identified as a "Rising Star" by the Association for Psychological Science in 2011 and received the Erik Erikson Early Career Award in 2014 from the International Society of Political Psychology. He is a long-time collaborator of Dr. Fiona Kate Barlow and currently holds an Associate Professorship at the University of Auckland, New Zealand.

DR. FIONA KATE BARLOW is a social psychologist specializing in the study of race relations. From 2012 to 2014, she held an Australian Research Council early career fellowship, and in 2016 accepted an Australian Research Council Future Fellowship Award. She is the recipient of the 2013 Society for Australasian Social Psychology Early Career



Researcher Award. During the majority of her role as co-editor of this handbook she was a Senior Lecturer at the School of Applied Psychology and Menzies Health Institute Queensland at Griffith University, Queensland, Australia. She is currently a Senior Research Fellow at the School of Psychology at the University of Queensland.
